Mayor Sheldon introduced Mr. Kevin Obos as the city's Acting Attorney. Mr. Obos read Resolution 20-142 by title only. Mayor Sheldon introduced Mr. Mark Lawson. Special Counsel Mark Lawson provided a brief explanation of the resolution and explained that public hearings for stormwater and fire assessments should be taken today. Mayor Sheldon opened the public hearing at 9:12 AM. Hearing and seeing none, Mayor Sheldon closed the public hearing at 9:12 AM. Mr. Lawson reported the process now was for Council to consider the resolution. Mayor Sheldon called for comments from Council.

Councilman Casto commended the city's Stormwater Department on how they handled the recent record rainfall. Councilman Casto noted that historical places in the city that had flooded in the past did not flood because of the assessment. Councilman Casto recommended approval. ## ITEM 2. RESOLUTION 20-143, ANNUAL FIRE ASSESSMENT FOR FY 2020-2021, PUBLIC HEARING.

Mr. Obos to read Resolution 20-143 by title only. Mayor Sheldon introduced Mr. Lawson. Special Counsel Mark Lawson provided a brief explanation of the resolution. Mr. Lawson reported the assessment had been validated by the local court as well as the concept had been approved by the Florida Supreme Court.

Mayor Sheldon opened the public hearing at 9:17 AM.

1. <u>Ms. Linda Herring</u> – Ms. Herring inquired if the assessment went before the Council before it was put in, how the 4% would be used, and if it would continue forever.

Mayor Sheldon called for further public comment. Hearing and seeing none, Mayor Sheldon closed the public hearing at 9:18 AM. Special Counsel Lawson discussed the sliding 4% scale. Mr. Lawson reported it was up to Council if the assessment went on forever and Council would need to consider this from year to year.

Mayor Sheldon called for comments from Council. Hearing and seeing none, Mayor Sheldon discussed the city not having an ad valorem tax and using this funding to make sure the city's life safety team has adequate funding. Councilman Jarman further explained the sliding 4%. Ms. Herring inquired as to how the city came up with her assessment. Mr. Lawson briefly discussed the evidentiary report included in the packet. Further discussion regarding how the assessment was determined took place.

Mayor Sheldon called for further comments. Hearing and seeing none, Councilman Chester moved to approve Resolution 20-143. The motion was seconded by Councilman Jarman. Mayor Sheldon asked the Clerk to call the roll. The motion passed by a unanimous roll call vote (5-0).
