A RESOLUTION OF THE CITY OF PANAMA CITY BEACH, FLORIDA, APPROVING AN AGREEMENT WITH PANAMA CITY TOYOTA, INC., FOR THE PURCHASE OF ONE TOYOTA CAMRY VEHICLE IN THE TOTAL AMOUNT OF \$27,862.50 AND AN AGREEMENT WITH MARIANNA TOYOTA, INC.
