

RESOLUTION NO. 22-17

A RESOLUTION OF THE CITY OF PANAMA CITY BEACH, FLORIDA, APPROVING AN AGREEMENT WITH PANAMA CITY TOYOTA, INC., FOR THE PURCHASE OF ONE TOYOTA CAMRY VEHICLE IN THE TOTAL AMOUNT OF \$27,862.50 AND AN AGREEMENT WITH MARIANNA TOYOTA, INC. FOR THE PURCHASE OF ONE TOYOTA RAV 4 UTILITY VEHICLE IN THE TOTAL AMOUNT OF \$29,426.50.

BE IT RESOLVED that the appropriate officers of the City are authorized to accept and deliver on behalf of the City certain Agreements as set out hereafter:

1. An agreement between the City and Panama City Toyota, Inc., for the purchase of (1) one Toyota Camry vehicle in the total amount of Twenty Seven Thousand, Eight Hundred Sixty Two Dollars and Fifty Cents (\$27,862.50), in substantially the form **attached** hereto as Exhibit "A" and presented to the Council today, with such changes, insertions or omissions as may be approved by the City Manager and whose execution shall be conclusive evidence of such approval; and

2. An agreement between the City and Marianna Toyota, Inc., for the purchase of (1) one Toyota Rav 4 vehicle in the total amount of Twenty Nine Thousand, Four Hundred Twenty Six Dollars and Fifty Cents (\$29,426.50), in substantially the form **attached** hereto as Exhibit "B" and presented to the Council today, with such changes, insertions or omissions as may be approved by the City Manager and whose execution shall be conclusive evidence of such approval.

THIS RESOLUTION shall be effective immediately upon passage.
