RESOLUTION NO. 22-106

A RESOLUTION OF THE CITY OF PANAMA CITY BEACH, FLORIDA, APPROVING AMOUNTS TO BE OFFERED TO LANDOWNERS ALONG FRONT BEACH ROAD FOR PURCHASE OF REAL PROPERTY INTERESTS FOR THE FRONT BEACH ROAD SEGMENT 3 PROJECT.

WHEREAS, the City has undertaken the acquisition of lands, property, property rights, and licenses to effect improvements which will support and enhance Arnold Road (f/k/a State Road 79) and Front Beach Road Segment 3 in furtherance of the Front Beach Road Community Redevelopment Plan (the "Project"); and

WHEREAS, City has reviewed surveys, appraisals, and title records for the subject properties, and now desires to engage the property owners to willingly self-licenses or easements to the City associated with the Project; and

WHEREAS, the license is to be used solely for sloping, grading, tying in, harmonizing and reconnecting existing features of the Licensor's property with the roadway improvements which are to be constructed, for a period of five years from execution or the completion of the project, whichever occurs first; and

WHEREAS, Florida Power and Light has confirmed its plans for the conversion of its electrical utilities for this Project segment, which plans necessitate the acquisition of permanent electrical easements to accommodate that underground conversion, operation and maintenance; and

WHEREAS, the City has approved a standard incentive schedule for calculating appropriate offers to landowners whose land the City seeks to acquire for right-of-way purposes in Resolution 06-02, as updated by Resolution 19-111.

NOW THEREFORE BE IT RESOLVED by the City Council that the following offers, calculated pursuant to the City approved incentive schedule, be approved as set forth below:
