

RESOLUTION NO. 22-126

A RESOLUTION OF THE CITY OF PANAMA CITY BEACH, FLORIDA, APPROVING ASSIGNMENT OF CONTRACTS FOR THE FRONT BEACH ROAD SEGMENT THREE PROJECT AND NORTH RICHARD JACKSON BOULEVARD IMPROVEMENT PROJECT TO C. W. ROBERTS CONTRACTING, INC.

WHEREAS, on March 15, 2021, the City approved that certain Agreement with GAC Contractors, Inc. relating to the construction of the Front Beach Road Segment 3 Project; and

WHEREAS, on January 22, 2022, the City approved that certain Agreement with GAC Contractors, Inc. relating to the construction of the North Richard Jackson Boulevard Improvement Project; and

WHEREAS, on March 18, 2022, the City received notice that C.W. Roberts Contracting, Inc. had acquired these project contracts, together with a request that the City consent to the assignment of these Agreements.

NOW THEREFORE, BE IT RESOLVED that the City hereby consents to, and the appropriate officers are authorized to execute and deliver on behalf of the City, the assignment of the following City Agreements with GAC Contractors, Inc. to C.W. Roberts Contracting, Inc.:


- a. Agreement relating to Front Beach Road Segment 3 Project, dated April 8, 2021; and
- b. Agreement relating to N. Richard Jackson Boulevard and PCB Parkway Intersection Improvements-Phase I Project, dated January 28, 2022;

and waives any objection to the defect in timing of the assignment required by those Agreements; **PROVIDED HOWEVER**, that C.W. Roberts Contracting, Inc provides its FDOT Certificate of Qualification, Performance Bonds and Payment Bonds for each project in an amount not less than 85% of the Contract Price for the faithful performance of these contracts, and Certificates of Insurance naming the City as an additional insured, all within 10 days of the effective date of this Resolution.


THIS RESOLUTION shall be effective immediately upon passage.
