We would be pleased to assist the City of Panama City Beach in evaluating eminent domain business damage claims on the above project. In addition, if requested by the City, we will review invoices and supporting workpapers submitted by business damage experts working on behalf of the affected business owners.

Because we will be submitting regular invoices with the expectation of being paid as the work is performed, we are willing to reduce our fees from the standard hourly rates normally charged on eminent domain matters. As a result, our fees for evaluating business damages will be based on our standard hourly rates reduced by \$25 per hour, as follows:

Our hourly rates may be adjusted annually in our billings based on normal increases in our rates charged to all clients. The above rates will be in effect until December 31, 2022. We will submit detailed bills to you on a regular basis, which will be based on these reduced hourly rates plus out-of-pocket expenses. It is our intention to structure our work so the appropriate levels of personnel from our staff are assigned to the various tasks in order to keep fees at a minimum.
