

RESOLUTION NO. 22-133

A RESOLUTION OF THE CITY OF PANAMA CITY BEACH, FLORIDA ACCEPTING THE RESULTS OF THE SUPER TUESDAY ELECTION AND CITY REFERENDUM, AUTHORIZING CODIFICATION OF APPROVED CHARTER AMENDMENTS AND TRANSMITTAL TO THE DEPARTMENT OF STATE.

WHEREAS, on January 13 2022, the City Council adopted Ordinance 1576, proposing numerous amendments to the City's Charter; and

WHEREAS, on January 27, 2022, the City Council adopted Resolution 22-90, calling a referendum and setting forth 8 ballot questions; and

WHEREAS, on April 19, 2022, the City conducted its regularly scheduled election for the office of Councilperson for Wards 1 and 3, and concurrently with that election held a referendum seeking approval of the amendments proposed by Resolution 22-90; and

WHEREAS, on April 22, 2022, the City's Canvassing Board certified the votes given for the offices, persons and referendums specified in that election.

NOW THEREFORE, BE IT RESOLVED THAT the City Council for the City of Panama City Beach hereby approves and accepts the results of the Election as indicated on the **attached** Exhibit A.

AND BE IT FURTHER RESOLVED that the appropriate officers and agents of the City are authorized and directed to incorporate into the Charter those amendments approved by a majority of the electors voting on such amendment, and to file the revised Charter with the Department of State.

THIS RESOLUTION shall become effective immediately upon passage.
