A RESOLUTION OF THE CITY OF PANAMA CITY BEACH, FLORIDA, CONVEYING PROPERTY TO THE STATE OF FLORIDA DEPARTMENT OF TRANSPORTATION FOR THE SR 30 (US 98) IMPROVEMENT PROJECT.

WHEREAS, the State of Florida Department of Transportation (FDOT) proposes to construct or improve State Road 30, Financial Project 2178385, in Bay County, Florida (the "Project"); and

NOW THEREFORE BE IT RESOLVED by the City Council of the City of Panama City Beach, Florida, that the application of the State of Florida Department of Transportation for a deed is for transportation purposes which is in the public or community interest and for public welfare and the land needed for transportation purposes is not needed for City purposes; that a deed in favor of the State of Florida Department of Transportation conveying all right, title and interest of the City of Panama City Beach, Florida, in and to said lands, should be drawn and executed by the appropriate officers of the City. Consideration shall be \$1.00.

**AND BE IT FURTHER RESOLVED** that a certified copy of this Resolution be forwarded forthwith to the State of Florida Department of Transportation at 1074 Highway 90, Chipley, Florida 32423.

THIS RESOLUTION shall be effective immediately upon passage.
