

RESOLUTION NO. 23-14

A RESOLUTION OF THE CITY OF PANAMA CITY BEACH, FLORIDA, APPROVING THE PURCHASE OF ANCILLARY INSURANCE COVERAGE AND SERVICES FROM HUMANA, INC., MINNESOTA LIFE, AND ALLSTATE INSURANCE COMPANY AS MORE PARTICULARLY DESCRIBED IN THE BODY OF THE RESOLUTION.

BE IT RESOLVED that:

1. The appropriate officers of the City are authorized to purchase on behalf of the City those certain insurance coverages and benefits from Humana, Inc., relating to employee dental insurance for the City, for the provided monthly rates for Employee-\$27.48 monthly, Employee/Spouse-\$62.33 monthly, Employee/Children- \$76.79 monthly, Family-\$114.96 monthly, in substantially the form of the quote **attached** as Exhibit A and presented to the Council today, with such changes, insertions or omissions as may be approved by the City Manager and whose execution shall be conclusive evidence of such approval.
2. The appropriate officers of the City are authorized to purchase on behalf of the City those certain insurance coverages and benefits from Humana, Inc., relating to employee vision insurance for the City, for the provided monthly rates for Employee-\$5.24 monthly, Employee/Spouse-\$10.50 monthly, Employee/Children- \$9.97 monthly, Family-\$15.67 monthly, in substantially the form of the quote **attached** as Exhibit B and presented to the Council today, with such changes, insertions or omissions as may be approved by the City Manager and whose execution shall be conclusive evidence of such approval.
3. The appropriate officers of the City are authorized to purchase on behalf of the City those certain insurance coverages and benefits from Minnesota Life Insurance Company relating to employee basic life

insurance, accidental death and dismemberment and supplemental life insurance for the City, in the estimated annual premium amount of Fifty-Three Thousand, Two Hundred Ten Dollars (\$53,210.00), in substantially the form of the quote **attached** as Exhibit C and presented to the Council today, with such changes, insertions or omissions as may be approved by the City Manager and whose execution shall be conclusive evidence of such approval.

4. The appropriate officers of the City are authorized to purchase on behalf of the City those certain insurance coverages and benefits from Minnesota Life Insurance Company relating to employee short-term disability insurance for the City, in the estimated annual premium amount of Eighty-One Thousand, Four Hundred Eighty-Seven Dollars (\$81,487.00), in substantially the form of the quote **attached** as Exhibit D and presented to the Council today, with such changes, insertions or omissions as may be approved by the City Manager and whose execution shall be conclusive evidence of such approval.
5. The appropriate officers of the City are authorized to purchase on behalf of the City those certain insurance coverages and benefits from Minnesota Life Insurance Company relating to employee long-term disability insurance for the City, in the estimated annual premium amount of Thirty-Seven Thousand, Two Hundred Twenty-Two Dollars (\$37,222), in substantially the form of the quote **attached** as Exhibit E and presented to the Council today, with such changes, insertions or omissions as may be approved by the City Manager and whose execution shall be conclusive evidence of such approval.
6. The appropriate officers of the City are authorized to purchase on behalf of the City those certain insurance coverages and benefits from Allstate Insurance Company relating to group accident insurance for the City, in the estimated annual premium amount of Twenty-Four Thousand, Forty-

Six Dollars (\$24,046.00), in substantially the form of the quote **attached** as Exhibit F and presented to the Council today, with such changes, insertions or omissions as may be approved by the City Manager and whose execution shall be conclusive evidence of such approval.

7. The appropriate officers of the City are authorized to purchase on behalf of the City those certain insurance coverages and benefits from Allstate Insurance Company relating to employee critical illness insurance for the City at the rates based upon employee elected benefit and age, set forth in the quote **attached** as Exhibit G and presented to the Council today, with such changes, insertions or omissions as may be approved by the City Manager and whose execution shall be conclusive evidence of such approval.
8. The appropriate officers of the City are authorized to purchase on behalf of the City those certain insurance coverages and benefits from Allstate Insurance Company relating to hospital indemnity insurance for the City, in the estimated annual premium amount of Eleven Thousand, Five Hundred Thirty-Three Dollars (\$11,533.00), in substantially the form of the quote **attached** as Exhibit H and presented to the Council today, with such changes, insertions or omissions as may be approved by the City Manager and whose execution shall be conclusive evidence of such approval.
9. The appropriate officers of the City are authorized to purchase on behalf of the City those certain insurance coverages and benefits from Allstate Insurance Company relating to employee legal services insurance for the City, in the estimated annual premium amount of Ten Thousand, Sixty-Two Dollars (\$10,062.00), in substantially the form of the quote **attached** as Exhibit I and presented to the Council today, with such changes, insertions or omissions as may be approved by the City Manager and whose execution shall be conclusive evidence of such approval.

10. The appropriate officers of the City are authorized to purchase on behalf of the City those certain insurance coverages and benefits from Allstate Insurance Company relating to employee cyber and identity protection insurance for the City, in the estimated annual premium amount of Five Thousand, Two Hundred Fifty-Six Dollars (\$5,256.00), in substantially the form of the quote **attached** as Exhibit J and presented to the Council today, with such changes, insertions or omissions as may be approved by the City Manager and whose execution shall be conclusive evidence of such approval.

THIS RESOLUTION shall be effective immediately upon passage.
