MINUTES of the **October 27, 2022** Regular Meeting of the City Council of the City of Panama City Beach, Florida, and when permitted or required by the subject matter, the Panama City Beach Community Redevelopment Agency.

Mayor Mark Sheldon called the October 27, 2022 regular meeting to order at 9:00 a.m.

A quorum was present with all five members of City Council. Others present were City Manager Drew Whitman, Assistant City Manager Holly White, City Attorneys Amy Myers and Cole Davis, City Clerk Lynne Fasone, Directors, staff, and members of the public and press.

Pastor Ramon Duvall from Beachside Fellowship Church led the invocation. Vice Mayor Paul Casto led the Pledge of Allegiance.

Mayor Sheldon provided community announcements. Mayor Sheldon called for approval of the October 11, 2022 special meeting/Parks & Recreation Workshop minutes and the October 13, 2022 regular meeting minutes. **Councilman Chester so moved. Councilmember Coburn seconded the motion. The minutes were unanimously approved by a roll call vote (5-0).**

Mayor Sheldon called for approval, additions and/or deletions to the agenda. Mayor Sheldon recommended adding a discussion about **"Luliwater Lake Next Steps"** as new Regular Agenda Item **#10**.

Mayor Sheldon called for additional additions and/or deletions. Hearing and seeing none, **Councilman** Chester moved to approve the amended agenda. Vice Mayor Casto seconded the motion. All were unanimously in favor of approval of the amended agenda, by a roll call vote (5-0).

PRESENTATIONS

Mayor Sheldon turned the floor over to Vice Mayor Casto. On behalf of Council, Vice Mayor Casto presented employees with years of service awards.

Mayor Sheldon welcomed Superintendent Bill Husfelt to the podium for an update on Bay District Schools.

Mayor Sheldon invited Wyatt Rothwell, Public Works Engineer, to the podium for a presentation on the Street Resurfacing Program FY2022 & FY 2023 (copy **attached**). Mayor Sheldon thanked Mr. Rothwell and called for comments from Council.

Mayor Sheldon inquired if straightening out the road, that was discussed during the Parks & Rec workshop, was included in this budget. Mr. Rothwell stated no. Assistant Manager White reported staff would bring back a task order for Council's consideration. Mayor Sheldon noted he'd like to see that at the November 10th meeting. Mayor Sheldon inquired out of the 17+ miles being improved, and how many roads would remain a D or F classification. Mr. Rothwell reported, if all of the roads being proposed were actually resurfaced, the City would have 26 D roads and 74 C roads remaining. Discussion regarding the roads being postponed this go-around took place. Mr. Rothwell further reported at the conclusion of this improvement project, if all roads being proposed were improved, 37.55% of roads would be A classification. Vice Mayor Casto discussed the purpose of staggering road improvements.

Councilmember Coburn inquired about manhole covers and why some were not flush with the roadway. Mr. Rothwell explained that typically meant the road was not constructed properly or there was some sort of settling and/or erosion. Mr. Rothwell reported staff would provide oversight to guard against that in the future, check density, etc.

Councilman Chester reported, in the past, Councilmembers had received complaints from homeowners about flooding after resurfacing projects. Councilman Chester inquired as to what the City would be doing to ensure that doesn't happen. Mr. Rothwell concurred and explained staff would focus heavily on doing the GEOTECH procedure to know the subsurface condition. Mr. Rothwell further discussed milling, reducing the elevation of a road, working with the Stormwater Department, roadside swells, and best practices. Councilman Chester thanked Mr. Rothwell and Director Jenkins for always being willing to meet with homeowners about roadway and stormwater issues.

Councilman Jarman noted he was interested in seeing what was instore for Manistee Drive because those folks have some stormwater issues. Councilman Jarman thanked Mr. Rothwell for the presentation.

Mayor Sheldon inquired as to the timeline. Mr. Rothwell reported the project would be bid out within the next three weeks, with a 30-day advertising period, and then it would be brought to Council as soon as possible. Mayor Sheldon noted January. Mr. Rothwell stated he believed so. Councilmembers thanked Mr. Rothwell.

PUBLIC COMMENTS - NON-AGENDA BUSINESS (LIMITED TO THREE MINUTES)

Mayor Sheldon opened the floor to non-agenda business public comments, limited to three minutes each.

<u>Molly Allen, Resident on Lullwater</u> – Ms. Allen thanked the Parks & Rec Department and the Audubon Society of Bay County for holding the first Audubon Bird Walk event at Aaron Bessant Park (ABP). Ms. Allen further commented on grass mowing during the event and there were no longer Killdeer birds at ABP because of fertilizing. Ms. Allen inquired about the status of the Lullwater Lake restoration project. Ms. Allen noted she was against the Stomwater Outfall Project.

Mayor Sheldon called for additional public comments. Hearing and seeing none, Mayor Sheldon closed the public comment portion of the agenda.

ADDED ITEM #10. DISCUSSION ITEM, LULLWATER LAKE NEXT STEPS.

Mayor Sheldon called for public comments.

Molly Allen, Resident on Lullwater - Ms. Allen noted that she would wait on her comments.

Hearing and seeing no further comments. Mayor Sheldon discussed the September 14 ceremony when the City received a \$6 million grant to help clean-up Lullwater Lake. Mayor Sheldon further reported the City had since heard that that funding maybe in limbo. Mayor Sheldon reported on November 13, after discussing with staff, he drove to Tallahassee and delivered a letter to Governor DeSantis' Chief of Staff, requesting the Governor's assistance. Mayor Sheldon added he was very encouraged, however, there were no guarantees of funding, but he was very encouraged. Mayor Sheldon recommended Council appropriate \$150,000, out of the general fund, to hire a stormwater consultant to work on, among other things, the master plan, surveying, water quality, conceptual designs, community outreach, etc. Mayor Sheldon added he felt this would be money well spent and would keep the project moving forward.

Councilman Jarman concurred and added that he was very optimist and agreed with keeping the project moving forward. Mayor Sheldon discussed how shovel ready projects seemed to be top priority with the State. Mayor Sheldon asked Council if they were fine with pushing forward tonight. Vice Mayor Casto offered his support, as long as the City had the funding. Assistant Manager White reported the City had the funding in the Stormwater Fund. Vice Mayor Casto concurred and added it would be money well spent.

Mayor Sheldon inquired as to the timeline. Director Jenkins reported about six months. Councilmember Coburn offered her support. Councilman Chester concurred.

Manager Whitman thanked Council for their direction and reported he would bring a task order back to Council to consider at its November 10th meeting. Mayor Sheldon thanked Manager Whitman.

Mayor Sheldon called for further public comment on Item #10.

<u>Molly Allen, Lullwater Lake Resident</u> – Ms. Allen inquired as to which consultant would be hired. Ms. Allen recommended the consultant who performed the baseline study some years ago. Ms. Allen reported she joined the St. Andrew Baywatch as a board member and the body write grants, etc. and offered their assistance.

Discussion regarding this being a State-owned Lake took place. Director Jenkins reported the City would use whatever information it had on file as a baseline and the consultant selected was Gemini Engineering, who had amazing subconsultants. Director Jenkins discussed getting an overall picture of the health of the lake, sampling, etc. Mayor Sheldon thanked Director Jenkins.

<u>CITY MANAGER REPORT</u> – No report.

CITY ATTORNEY REPORT - No report.

COUNCIL COMMENTS - Mayor Sheldon invited comments from Council.

Councilman Jarman commented, in response to Ms. Allen's comments, there would be many agencies involved with Lullwater Lake project and he understood Ms. Allen to be in favor of removing the sediment out of Lullwater Lake. Councilman Jarman recommended Council move forward with a task order for the north Alf Coleman sidewalk project, from Arnold High School to Back Beach Road. Manager Whitman reported staff estimated the cost to be approximately \$500,000 and it came back yesterday at \$437,000. Councilman Jarman noted he was in favoring of moving forward with the project. Mayor Sheldon offered his support. Vice Mayor Casto offered his support, as long as funds were available. Assistant Manager White reported staff was in the process of finishing up cash carry forwards from FY22, the City had a very good year, so there should be some extra cash coming forward, there should be sufficient amount to fund this project. Manager Whitman thanked Council for direction and commented he would bring this back for Council's consideration at the November 10 meeting.

Mayor Sheldon asked Council to keep in their minds, possibly for discussion on November 10, the north Richard Jackson project. Mayor Sheldon also recommended discussing, at the next meeting, art or signage in the roundabout, the City's new gateway. Council discussed power and irrigation already in place in the roundabout. Mayor Sheldon extended a thank you and well wishes to City intern, Riani Pokipala, whose last day would be October 31st.

With nothing further, Mayor Sheldon adjourned the meeting by unanimous consent at 10:06 a.m.

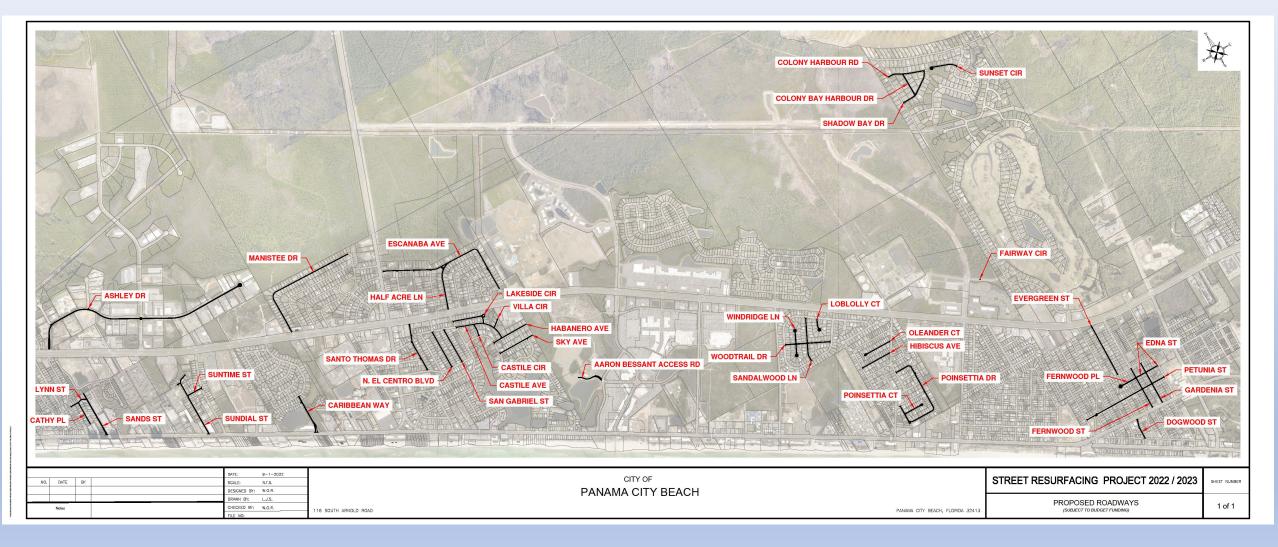

Roadway Design Steps

- 1) Begin at the Roadway Conditions Assessment and Resurfacing Schedule.
 - a. Evaluate roads based off both private and capital projects in the vicinity.
 - b. Evaluate roads based off deterioration levels since they were originally evaluated.
 - c. Select similar graded roads within close vicinity to each other to reduce mobilization overhead.
 - d. Select clustered roads in as many of the wards within the reasonable scheduled time.
 - e. Begin a cost estimate of roadways to ensure within budgetary bounds

Roadway Design Steps (continued)

- 2) Site Visit to evaluate selected roads to evaluate condition in person and select Geotechnical Coring and Boring locations.
 - a. 4" Core to Measure Thickness of Roadway
 - b.5' Boring to evaluate base, subbase, subgrade, and water table.
- 3) CAD Technician creates alignments of Roadways.
 a. Locations for Geotechnical Coring and Borings are labeled.
 b. Notations are added to provide direction
- 4) Geotechnical Engineering
 - a. Proposal is provided based on alignments and prescriptive expectations.
- 5) Bid Documents are typically begun during this time.

- 7) CADD Technician finalizes drawings
- 8) Peer Review of Drawings
- 9) Bid Out

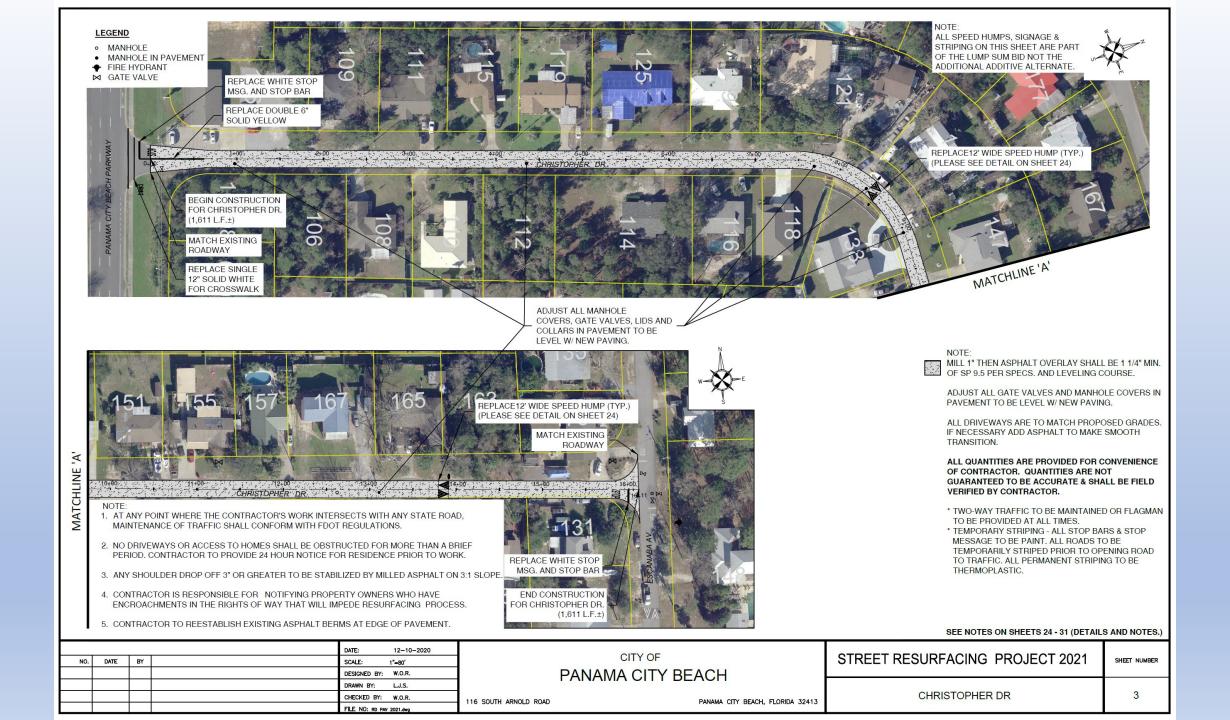
