CRA Progress

• Work on Segment 3, which runs from the intersection of State Road 79 (Arnold Road) and Panama City Beach Pkwy. south to Front Beach Road, also including Front Beach Road from Cabana Cay Blvd. east to Lullwater Drive, continues to make significant progress. The project is approximately 53% complete. The City's contractor is currently focusing efforts on the east side of Arnold Road from the new roundabout to PCB Pkwy., relocating utilities and grading earthwork for the future northbound travel lanes. Work also continues on the north side of Front Beach Road between the roundabout and Lullwater Drive, installing storm drainage, sanitary sewer, and new water mains.



 The Alf Coleman Road project is expected to begin this month and will be completed in mid-summer 2024.

Golf Cart and Low-Speed Vehicle (LSV) Dos and Don'ts

- For the safety of our residents and visitors, rules and regulations are in place that govern the operation of golf carts and low-speed vehicles (LSVs) in the City limits of Panama City Beach.
- LSVs and golf carts are not the same thing. Golf carts may not be on any road with speeds exceeding 25 mph. Side-by-sides and other all-terrain vehicles are not allowed on City roadways.
- Golf carts and all LSVs are prohibited from tram lanes. Those lanes are intended for tram and bicycle use only.
- An LSV is a four-wheeled vehicle with a top speed greater than 20 mph but less than 25 mph. These vehicles are never allowed to drive on Panama City Beach Parkway aka Back Beach Road, Hutchison Boulevard aka Middle Beach Road, or anywhere the speed limit exceeds 35 mph.
- LSVs must comply with Florida safety standards, Section 316.2122 Florida Statutes.
- Rules for operation include:
 - LSVs can only operate on streets where the speed limit is 35 mph or less.
 - LSVs must be equipped with headlamps, stop lamps, turn signal lamps, tail lamps, reflex reflectors, parking brakes, rearview mirrors, a windshield, seat belts and have a VIN number.
 - Any person operating an LSV must have a valid driver license in his or her possession.
 - LSVs must be registered, insured, titled, and have a valid license plate.
 - Operators of LSVs must follow the rules of the road, wear seat belts, and properly utilize child car seats if applicable.
- Violations of these rules and regulations may result in a fine.
