Mayor Mark Sheldon called the October 12, 2023, regular meeting to order at 6:00 p.m.

Mayor Sheldon led the invocation and the Pledge of Allegiance. Mayor Sheldon provided community announcements. Mayor Sheldon called for approval of the September 28, 2023, Regular Meeting Minutes. PRESENTATION

On behalf of Council, Mayor Sheldon presented Connilee Jones with a Certificate of Special Recognition for being selected the Boys & Girls Club October 2023 honoree. Mayor Sheldon presented Fire Chief Ray Morgan with a Fire Prevention Week Proclamation.

PUBLIC COMMENTS - NON-AGENDA BUSINESS (LIMITED TO THREE MINUTES)

Mayor Sheldon opened the floor to non-agenda business public comments, limited to three minutes each.

- 1. <u>Captain Gary Wayne Beck, 2601 Beach Street</u> –Mr. Beck commented on the Constitution and Bill of Rights and stated his rights had been violated for a variety of reasons.
- 2. <u>Burnie Thompson</u> Mr. Thompson commented on a lawsuit between the City and four plaintiffs being settled and inquired if the settlement funds came from the City budget or insurance money. Mr. Thompson further commented on the city's FY2023-2024 budget.
- 3. <u>Genese Hatcher</u> Ms. Hatcher commented and expressed concern about golf carts parking at Beach Access #47. Ms. Hatcher further commented that golf carts were damaging her house and generally destroying her and the City's property. Ms. Hatcher asked that the City look at whether parking should be prohibited at that access.

Mayor Sheldon called for additional public comments. Hearing and seeing none, Mayor Sheldon closed the public comment portion of the agenda.

REGULAR AGENDA- DISCUSSION/ACTION ITEMS

ITEM 1. ORDINANCE NO. 1633 ADDING A NEW CHAPTER 30 "PENSIONS" FOR PANAMA CITY BEACH POLICE OFFICERS' PENSION PLAN, FIRST READING / PUBLIC HEARING.

Mayor Sheldon introduced City Attorney Cole Davis. Mr. Davis read Ordinance 1633 by title only. Mayor Sheldon opened the public hearing. Hearing and seeing no comments, Mayor Sheldon closed the public hearing.

Mayor Sheldon noted this item was available to Council. Assistant City Manager White explained this Ordinance, as well as the next two, would codify all prior ordinances pertaining to the City's three Pension Plans into the City's Code of Ordinances into a new Chapter 30. Ms. White further explained the Ordinance proposed to incorporate two minor changes: (1) the mortality table utilized to calculate the actuarial equivalent was updated from the 1983 Group Annuity Mortality Table for Males to the RP 2000 Generational Mortality Table; and (2) a change to the effective date of an election to participate in the DROP to the first day of the first calendar month subsequent to the election date, previous language indicated an effective date on the first day of the first calendar month at least fifteen (15) business days after an election was received from a Member; however, the City historically had not held Members to the

fifteen (15) business days. Mayor Sheldon thanked Ms. White. Councilman Chester moved to approve Ordinance 1633. Councilmember Coburn seconded the motion. Mayor Sheldon called for further discussion. Hearing and seeing none, Ordinance 1633 was unanimously adopted by a (4-0) roll call vote.
