INVITATION TO BID

PCB24-12 ITB LANDSCAPE MAINTENANCE SERVICES CITY MAIN CAMPUS FY2024

The City of Panama City Beach is accepting electronic (e-submission) and sealed Bids from qualified contractors to provide landscaping maintenance services to the City of Panama City Beach's Main Campus and the newest fire station located at 11911 Hutchison Blvd which is currently under construction. The Contractor shall provide all materials, equipment and labor to complete the project.

The bid must conform to Section 287.133(3) Florida Statutes, with respect to Public Entity Crimes.

All Bids must be received no later than **Friday**, **January 12**th, **2024**, **at 9:00AM CDT** at which time all Bids will be publicly opened and read.

- Electronic Bids will only be accepted when submitted through DemandStar's Bid portal. Emailed submissions will not be accepted.
- Alternatively, one original and one electronic copy (USB flash drive preferred) may be delivered to the City Hall Office at the address below. Any sealed Bid submitted on paper must identify and clearly mark the Bid # PCB24-12 LANDSCAPE MAINTENANCE SERVICES CITY MAIN CAMPUS FY2024 on the package. Bidder's name and return address should be clearly identified on the outside of the package. Receipt of a Bid by any Panama City Beach Office, receptionist, or personnel other than the City Hall's front desk does not constitute "receipt" as required by this solicitation. The City will not be responsible for mail delays, late or incorrect deliveries. The time/date stamp in the City Hall or on DemandStar will be the official authority for determining late Bids.

The City reserves the right to accept or reject any or all Bids (in whole or in part) with or without cause and to waive technicalities, irregularities, or informalities.

If necessary, questions will be answered as ADDENDA and will be issued to the Contract Documents and posted on the City's website. It is the sole responsibility of the bidder to determine if any addenda have been issued. The due date for questions will be **4:00PM CDT on Friday**, January 5th, 2024.

INFORMATION FOR BIDDERS

It is the intention of this Invitation to Bid (ITB) to award a contract to provide landscaping maintenance service to the City of Panama City Beach's Main Campus and the newest fire station located at 11911 Hutchison Blvd, which is currently under construction. The Contractor shall provide all materials, equipment, and labor to complete the project.

Potential bidders to the solicitation are expected to review all materials contained herein and prepare responses accordingly.

After the BIDS have been submitted, the BIDDER shall not assert that there was a misunderstanding concerning the quantities of WORK or of the nature of the WORK to be done.

Submittal of a Bid in response to this Invitation for Bid constitutes an offer by the Bidder. Bids which do not comply with these requirements may be rejected at the option of the City. It is the Bidder's responsibility to ensure that Bid submittals are in accordance with any addenda(s) issued. Bids not submitted with all the required documents may be rejected.

Failure to comply with the solicitation requirements, specifications, terms and conditions, including those specifying information that must be submitted with a response, may be grounds for rejecting a bid or response.

The City shall award the contract to the lowest fully responsive and responsible Bidder(s); provided, that the City may award the contract to a Bidder(s) other than the lowest Bidder should it find the lowest Bidder does not offer the reliability, quality of service or product afforded by such other Bidder. Where a Bid other than the lowest Bid is taken, the City shall state the reasons upon which such award was made.

The City reserves the right to accept or reject any or all Bids (in whole or in part) with or without cause, to waive any technicalities, irregularities, or formalities, or to accept the Bid(s) which in its judgement best serves The City of Panama City Beach.

TERMS AND CONDITIONS

ADDENDUM: If it becomes necessary to revise or amend any part of this Invitation for Bid, the City's Purchasing Manager will furnish the revision by written Addendum through the City's solicitation hosting platform at <u>www.demandstar.com</u>. Addenda information will also be posted online at the City of Panama City Beach website: <u>https://www.pcbfl.gov</u>. Bidders are solely responsible to ensure they have received all addenda(s) prior to submitting their Bid.

ANTI-DISCRIMINATION: The Bidder certifies compliance with the non-discrimination clause contained in Section 202. Executive Order 11246, as amended by Executive Order 11375, relative to equal employment opportunity for all persons without regard to race, color, religion, sex, or national origin.

AWARD: The City shall award the contract to the lowest fully responsive and responsible Bidder(s); provided, that the City may award the contract to a Bidder(s) other than the lowest Bidder should it find the lowest Bidder(s) does not offer the reliability, quality of service or product afforded by such other Bidder(s).

BIDDER ACKNOWLEDGEMENT: By submitting a Bid, the Bidder certifies and or acknowledges that he/she has full knowledge of the scope, nature, quality of product to be provided, and/or quality of work to be performed.

Submission of a Bid indicates acceptance by the individual or vendor of the conditions contained in this invitation to Bid, unless clearly and specifically noted in the Bid submitted and confirmed in the contract between the City of Panama City Beach and the individual or vendor selected.

BIDDER EXPENSES: The City is not responsible for any expenses that a Bidder may incur in preparing and submitting Bids called for in this request. The City will not pay for any out-of-pocket expenses, such as word processing, photocopying, postage, per diem, travel expenses and the like, incurred by the Bidder. The City will not be liable for any costs incurred by the Bidder in connection with any interviews/presentations (i.e., travel, accommodations, etc.).

CHANGE ORDER: No out-of-scope services shall be performed in the absence of prior written authorization in the form of a written supplemental agreement and issuance of an appropriate amendment to the contract.

CONE OF SILENCE: The City observes a cone of silence and policies for ethical and professional behavior on all advertised solicitations. Potential bidders and their agents must not communicate in any way with the City Council, City Manager, or any City Staff other than the Purchasing Manager in reference to or relation to this solicitation. This restriction is effective from the time of bid advertisement until an award is made by the City Council. Such communication may result in disqualification.

CONFLICT OF INTEREST: The award of any Contract hereunder is subject to the provision of Chapter 112, Florida Statutes. Bidders must disclose with their Bid the name of any officer, director, partner, proprietor, associate, or agent which is also an officer or employee of the City or of its boards or committees. Bidders must disclose the name of any officer or employee of the City who owns, directly or indirectly, an interest of five percent (5%) or more in the Bidder's organization or any of its branches or affiliate companies.

DEFAULT/FAILURE TO PERFORM: The City of Panama City Beach shall be the sole judge of nonperformance, which shall include any failure on the part of the successful Bidder to accept the award, to furnish required documents, and/or fulfill any portion of this contract within the time stipulated. Upon default by the successful Bidder to meet any terms of this agreement, the Purchasing Division will provide the Bidder three (3) days notice (weekends and holidays excluded) to remedy the default. Failure on the Bidder's part to correct the default within the required three (3) days shall result in the contract being terminated, upon the Purchasing Manager notifying in writing the Bidder of its intentions and the effective date of the termination. The following shall constitute default: The City of Panama City beach may terminate the Contract if the Bidder fails to (1) deliver the product within the time specified in the Contract, (3) honor any term of the Contract, or (4) abide by any statutory, regulatory, or licensing requirement.

DEVIATION FROM SPECIFICATION: Any deviation from specifications must be clearly stated, explained in detail, and accepted by the City Manager in writing. Otherwise, items offered are expected to be in strict compliance with specifications and the successful Bidder shall be held accordingly.

DOING BUSINESS WITH THE CITY. When a vendor is awarded a contract with the City, the City will request a copy of the vendor's completed W-9 to register the vendor in the City's financial system for invoice processing and payment. Vendors may choose ACH or virtual card for payments, as these forms of payment result in quicker payment of invoices.

E-VERIFY: The awarded Bidder becomes obligated to comply with the provisions of Section 448.095, Fla. Stat., "Employment Eligibility", as amended from time to time. This includes but is not limited to utilization of the E-Verify System to verify the work authorization status of all employees hired after January 1, 2021, and requiring all sub-Bidders to provide an affidavit attesting that the sub-Bidder does not employ, contract with, or subcontract with, an unauthorized alien. The Bidder shall maintain a copy of such affidavit for the duration of the contract. Failure to comply will lead to termination of this Contract, or if a sub-Bidder knowingly violates the statute, the subcontract must be terminated immediately. Any challenge to termination under this provision must be filed in the Circuit Court no later than twenty (20) calendar days after the date of termination. If this contract is terminated for a violation of the statute by the Bidder, the Bidder may not be eligible for or awarded a public contract for a period of one (1) year after the date of termination.

FORCE MAJEURE: Neither the City nor the Bidder shall be liable for its failure to perform hereunder due to contingencies beyond its reasonable control, including but not limited to wars, acts of God, acts of terror, labor disputes, flood, windstorm, explosion, riots, sabotage, and fire and pandemic, provided that prompt notice of such delay is given to the other party. The time for performance shall be extended for a period equal to the duration of the Force Majeure.

INDEMNIFICATION: Regardless of the coverage provided by any insurance, the successful Bidder shall indemnify, save harmless and defend the City, its agents, servants, or employees from and against any and all claims, liability, losses and/or causes of action which may arise from any negligent act or omission of the successful Bidder, its sub-Bidders, agents, servants or employees during the course of performing services or caused by the goods provided pursuant to these Bid documents and/or resultant contract.

If any third-party claim is made against the City that, if sustained, would give rise to indemnification liability of the Bidder under this Agreement, the City shall promptly cause notice of the claim to be delivered to the successful Bidder and shall afford the Bidder and its counsel, at the Bidder's sole expense, the opportunity to join in defending or compromising the claim.

INSURANCE: Bidder shall at its expense maintain in force during the Term the insurance on policies and insurers acceptable to the City as required by the City's Insurance Requirements attached hereto as Exhibit "A".

Within thirty (30) days of the date of the Award, and thereafter upon the written request of the City, Bidder shall furnish to the City such certificates of coverage and certified copies of policies pursuant to the City's Insurance Requirements. In order to satisfy this provision, the documentation required by this part must be sent to the following address: ATTN: Risk Management Director, 17007 Panama City Beach Parkway, Panama City Beach, Florida 32413.

INTERPRETATIONS: Any questions concerning conditions and specifications shall be directed to the Purchasing Manager. Interpretations that may affect the eventual outcome of this Bid will be furnished in writing to all prospective Bidders. No interpretation shall be considered binding unless provided in writing by the City of Panama City Beach.

MINOR IRREGULARITIES/INFORMALITIES: The City of Panama City Beach reserves the right to both waive any irregularities or informalities in Bids and to determine, in its sole discretion, whether or not informality is minor.

NON-COLLUSION: The Bidder certifies that this Bid has not been arrived at collusively or otherwise in violation of federal, state, or local laws. Bidder shall certify that this offer is made without prior understanding, agreement, or connection with any corporation, firm or person submitting an offer for the same materials, services, supplies or equipment and is in all respects fair and without collusion or fraud.

No premiums, rebates or gratuities are permitted, either with, prior to or after any delivery of material or provision of services. Any violation of this provision may result in the Contract cancellation, return of materials or discontinuation of services.

NOTIFICATIONS: The City of Panama City Beach's official website for notices, Bids, addendums, and other documents is located at <u>https://www.pcbfl.gov</u>. Bidders are also advised that <u>www.demandstar.com</u> is one of the City's sourcing methods of notices, addendums, Bids, and other documented communications for the procurement process. The City is not under any obligation and does not guarantee that Bidders will receive email notifications concerning the posting, amendment or close of solicitations. Bidders are responsible for checking <u>www.demandstar.com</u> or <u>https://www.pcbfl.gov</u> for information and updates concerning solicitations or contact the Purchasing Manager.

OPTIONAL CONTRACT USAGE BY OTHER GOVERNMENTAL AGENCIES: All Bidders submitting a response to this Invitation to Bid agree that such response also constitutes a proposal to other Florida governments under the same conditions, for the same contract price, and for the same effective period, should the Bidder feel it is in their best interest to do so.

PAYMENT: Upon acceptance of work by the City, the City shall make payment to the Bidder in accordance with the Local Government Prompt Payment Act, Chapter 218, Florida Statutes. The City reserves the right, with justification, to partially pay any invoice submitted by the Bidder when

requested to do so by the City's Department Representative. All invoices shall be directed to Accounts Payable, City of Panama City Beach. Payment for invoices will be made via ACH or Virtual Credit Card only.

PURCHASING POLICIES. For more information on the City's purchasing policies and procedures, or to review the City's Procurement Manual, please visit the City's website at <u>www.pcbfl.gov</u>.

PUBLIC ENTITY CRIMES: By submission of response to the City's Invitation to Bid, Bidder acknowledges and agrees to the following: A person or affiliate who has been placed on the Convicted Vendor List following a conviction for a public entity crime may not submit a Bid on a contract to provide any goods or services to a public entity, may not submit a Bid on a contract with a public entity for the construction or repair of a public building or public work, may not submit Bids for leases of real property to a public entity, may not be awarded or perform work as a Successful Bidder, contractor, supplier, sub-Bidder, or consultant under a contract with any public entity, and may not transact business with any public entity in excess of the threshold amount provided in Section 287-017 Florida Statues, for CATEGORY TWO for a period of 36 months from the date of being placed on the Convicted Vendor List (Section 287.133, Florida Statutes).

PUBLIC RECORDS: Certain exemptions to the public records law are statutorily provided for in Section 119.07, Florida Statues. If the Bidder believes any of the information contained in his or her response is exempt from disclosure, then the Bidder must in her or her response specifically identify the material which is deemed to be exempt and cite the legal authority for the exemption. Otherwise, the City will treat all materials received as public records once that information is determined to be available for public inspection.

If the City rejects all Bids or replies submitted in response to a competitive solicitation and the City concurrently provides notice of its intent to reissue the competitive solicitation, the rejected Bid or replies remain exempt from Section 119.07(1) and Section 24(a) of the State Constitution until such time as the City provides notice of an intended decision concerning the reissued competitive solicitation, or until the City withdraws the reissued competitive solicitation. A Bid, proposal, or reply is not exempt for longer than 12 months after the initial agency notice rejecting all Bids, or replies.

The City is a public agency subject to Chapter 119, Florida Statutes. The Bidder shall comply with Florida's Public Records law. Specifically, the Bidder, shall:

- a. Keep and maintain public records required by the public agency to perform the service.
- b. Upon request from the public agency's custodian of public records, provide the public agency with a copy of the requested records or allow the records to be inspected or copied within a reasonable time at a cost that does not exceed the cost provided in this chapter or otherwise provided by law.
- c. Ensure that public records that are exempt or confidential and exempt from public records disclosure requirements are not disclosed except as authorized by law for the duration of the contract term and following completion of the contract if the Bidder does not transfer the records to the public agency.
- d. Upon completion of the contract, transfer, at no cost, to the public agency all public records in possession of the Bidder or keep and maintain public records required by the public agency to perform the service. If the Bidder transfers all public records to the public

agency upon completion of the contract, the Bidder shall destroy any duplicate public records that are exempt or confidential and exempt from public records disclosure requirements. If the Bidder keeps and maintains public records upon completion of the contract, the Bidder shall meet all applicable requirements for retaining public records. All records stored electronically must be provided to the public agency, upon request from the public agency's custodian of public records, in a format that is compatible with the information technology systems of the public agency.

The failure of the Bidder to comply with the provisions set forth in this section shall constitute a material breach of Agreement and shall be cause for immediate termination of the Agreement.

REQUEST FOR ADDITIONAL INFORMATION/CLARIFICATION: The Bidder shall furnish such additional information/clarification as the City may reasonably require. This includes but is not limited to information that indicates Bidder financial resources as well as the ability to provide and maintain the goods or services requested.

RESPONSIBLE VENDOR DETERMINATION: Respondent is here notified that Section 287.05701, Florida Statues, requires that the City may not request documentation of or consider a vendor's social, political, or ideological interests when determining if the vendor is a responsible vendor.

RIGHT TO REJECT: Bidders are expected to examine the specifications, delivery schedules, Bid prices and extensions and all instructions pertaining to supplies and services. Failure to do so will be at the Bidder's risk. Only the City of Panama City Beach reserves the right to reject all Bids, or any part of any Bid deemed necessary for the best interest of the City. The City may reject any response not submitted in the manner specified by the solicitation documents.

If Bidder purports to add terms or conditions to its Bid, takes exception to any provisions of the Bidding Documents, or attempts to alter the contents of the Contract Documents for the purposes of the Bid, whether in the Bid itself or in a separate communication to the City, then the City will reject the bid as nonresponsive.

RECOMMENDATION OF AWARD INFORMATION: Notice of Award, Bids currently available, and Tabulation sheets will be available online at <u>www.demandstar.com</u>. Bidders who do not have Internet access may request a copy of the tabulation by contacting the Purchasing Manager. (NOTE: information will be provided in accordance with the requirements contained in the section above regarding PUBLIC RECORDS).

RESPONSIBLE BIDDER: A Bidder, business entity or individual who submits a Bid and who has furnished, when required, information and data to prove that its financial resources, production or service facilities, personnel, service reputation and experience are adequate and fully capable to make satisfactory delivery of the goods or services described in the Bid. The City may review vendor performance on City Contracts, and other public entity contracts, in arriving at a

determination as to whether a Bidder meets the definition of a responsible vendor who may be recommended for award.

RESPONSIVE BIDDER: A Bidder, business entity or individual who has submitted a Bid or Bid that fully conforms in all material respects to the Invitation to Bid and all of its requirements, including all form and substance.

TAX EXEMPTIONS: The City of Panama City beach is tax exempt. The City of Panama City Beach's tax-exempt number is 85-8012646361C-4.

TIME FOR CONSIDERATIONS: Bids will be irrevocable after the time and date set for the opening of Bids and for a period of sixty (60) days thereafter.

SCOPE OF WORK/SPECIFICATIONS

GENERAL INFORMATION

The purpose of this bid is to secure landscaping maintenance services for the City of Panama City Beach's Main Campus and new fire station (under construction at 11911 Hutchison Blvd). The City is seeking a qualified contractor who shall provide all the materials, equipment, and labor required.

Each bidder shall become fully informed as to the extent of services required prior to submitting a bid. No consideration will be granted for any alleged misunderstanding of the work to be done, and it is understood that the submission of a bid is an agreement with all the items and conditions referred to herein.

LOCATION OF WORK:

All work will be conducted on the City of Panama City Beach Main Campus surrounding the City Hall Annex building. Reference Exhibits A & B (Map and Plans). Location details are listed below:

- 1. **City Hall Annex** Located at 17007 Panama City Beach Pkwy. This includes the walled courtyard/patio on the west side of the building outside of the council chambers and the outdoor enclosed mechanical area on the southwest corner of the building)
- 2. Public Services Administration Building: Located at 116 South Arnold Road.
- 3. Plaza: Located between the Police Station and the Tourist Development Council Building.
- 4. Panama City Beach Police Department: Located at 17115 Panama City Beach Pkwy.
- 5. Panama City Beach Fire Department Station #31: Located on Campus at 17121 Panama City Beach Parkway. This includes both small stormwater ponds adjacent to the building. *This location is currently under construction with an estimated completion date of July 15, 2024. Please see Exhibit A for the location and Exhibit B for the Landscape plans. All bids should be based on maintenance for what is shown in the approved landscape plans. Service Charges shall not be issued until after construction is complete and is accepted by the City. The winning contractor will be notified in writing when services in this section are to begin.
- 6. Fuel Barn: Located to the south of the Fire Department off San Vincente Street.
- 7. Police and Fire Storage: Located on the City Main Campus at 111 San Vincente Street between the Fire Station #31 and the Police Impound Lot. *This location is currently under construction with an estimated completion date of July 15, 2024. Please see Exhibit A for the location and Exhibit B for the Landscape plans. All bids should be based on maintenance for what is shown in the approved landscape plans. Service Charges shall not be issued until after construction is complete and is accepted by the City. The winning contractor will be notified in writing when services in this section are to begin.
- 8. **Police Department Impound Lot**: Located to the south of the Fuel Barn on the southwest corner of the campus at the intersection of Firenzo Ave and San Vincente Street.

- 9. **Storm Water Pond #1**: Located on the south-central side of the campus. Running from the driveway access from Firenzo Avenue to the Plaza.
- 10. Panama City Beach Fire Department Station #32 (Reference Exhibit C): Located at 11911 Hutchison Blvd. *This location is currently under construction with an estimated completion date of November 15, 2024. Please see Exhibit C for the location and the Landscape plans. All bids should be based on maintenance for what is shown in the approved landscape plans. Service Charges shall not be issued until after construction is complete and is accepted by the City. The winning contractor will be notified in writing when services in this section are to begin.

This contract does not include services for the Panama City Beach Tourist Information Center. This landscaping is maintained under a separate Tourist Development Council (TDC) contract.

SPECIFICATIONS

GENERAL:

The work to be performed and the terms and conditions of performance of such work and payment therefore by the City of Panama City Beach shall be materially as described in the form of the **Landscape Maintenance Agreement**. The agreement shall be for a term of two (2) years, beginning **February 1, 2024**. The City of Panama City Beach will reserve the right to extend the Agreement upon the same terms and conditions for two (2) additional one (1) year extensions.

THIS WORK DOES NOT INCLUDE Tourist Development Council Building & surrounding landscape shown on Exhibit A located at 17001 Panama City Beach Pkwy, or any of the other City owned and maintained properties not mentioned above.

The proposed specifications below will cover, but not be limited to, the following:

- A. The CONTRACTOR shall furnish all labor, materials, equipment, tools, services and incidentals to complete all work required by this scope of work, except such items the Owner specifically agrees in the Contract to supply or furnish to or for the use of Contractor. Any equipment materials or services not specifically described in the Contract Documents, which may be fairly implied as required thereby or necessary to complete the Work for the use intended shall be within the scope of the Contractor's Work hereunder. All Work shall be performed by trained, properly supervised personnel in accordance with accepted horticultural and safe practices including compliance with all maintenance of traffic standards and procedures.
- B. The CONTRACTOR shall follow accepted horticultural practices to keep the areas to be landscaped attractive and clean in appearance and maintain all plants and turf in a healthy, vigorous condition. All work shall be performed in a professional manner, using quality equipment, methods and materials, all of which must be maintained and operated to the highest industry standards. The workers shall be neat in appearance, wear a uniform which identifies the contractor, and perform their work in a professional manner.
- C. The CONTRACTOR shall assume responsibility for the proper maintenance, survival and

condition of all plants, turf and irrigation components for the period of this contract.

D. GRASS CUTTING: Prior to mowing, any debris or litter in grass or planting areas shall be removed and legally disposed offsite, in accordance with all applicable laws, rules and regulations. Grass shall be cut at a bench height of three inches. The Contractor shall employ mowing equipment direction patterns to permit recycling of clippings where possible to present a neat appearance. Mowers shall have sharp cutting edges; uneven cutting, plowing, or gouging of the soil shall not be permitted. Cuttings shall be legally disposed of offsite, in accordance with all applicable laws, rules and regulations. Dependent on weather, growing conditions and/or special events, mowing frequency may be adjusted with the total not to exceed 42 mows per year. Hand cutting around guard rails, back flow preventers, head walls, fire plugs, trees, large shrubs, and the like are part of the mowing process. It is the responsibility of the CONTRACTOR to mow the contract areas on a cycle as noted in the chart below. The frequency will be as follows with the tentative dates for the first year of service as follows:

E. EDGING AND TRIMMING: The use of herbicides shall not be allowed for the purpose of eliminating or reducing normal mechanical edging along paved edges.

Mechanically edge all planting beds that are adjacent to turf areas at every mowing cycle. All concrete walks and curbing (if applicable) shall be edged as required to maintain a neat appearance. In addition, whenever mowing, the Contractor shall closely trim around all trees, guys, planting areas, structures, etc. utilizing a "weed eater" type device. Trimming

shall be at a height of three inches so that grass is not destroyed. The Contractor will be responsible to repair at no cost to the Owner any damage to property caused by Contractor's trimming work. Beds shall be edged as necessary to maintain a definition of outline per the original design intent.

F. FUNGICIDE, PESTICIDES AND HERBICIDES: Any needed fungicide, pesticide or herbicide application due to disease or pest problems shall be monitored and reported to the Owner. Required application will be performed by the Contractor in accordance with the manufacturer's directions and all applicable local, State and Federal regulations. The Owner will reimburse the Contractor's actual out-of-pocket material costs with appropriate backup original invoices from the supplier; Contractor must obtain Owner's written approval prior to incurring any material costs for any repairs. After applying an herbicide, the irrigation system is to be turned off for a period of forty-eight (48) hours unless the label recommends "watering in." After the requested "dry period" the irrigation system is to be turned back on.

Pre-emergent weed control is required in all bed areas. Post emergent weed control shall be applied as needed to control weed growth in landscape beds, any pavement cracks, and turf. Pre-emergent weed control shall be applied two to three times per growing season. All personnel involved in the chemical program are to receive proper training and follow the operating guidelines provided by the DOT for chemical control. Contact the local County Agricultural Extension Service for additional information regarding herbicides, pesticides and required licenses.

Remove mechanically or by herbicide treatment all invasive exotic species (including aquatics) on an as needed basis. This includes all noxious weeds, FLEPPC (Florida Exotic Pest Plant Council) Category 1 and Category 2 listed plants, as well as Typha sp. (cattails).

- G. PRUNING AND TRIMMING: All areas shall be annually pruned or trimmed as needed to maintain an attractive appearance, maintain visibility and eliminate any safety problem. Clear trunk to be achieved and maintained is 8 feet for canopy shade trees, and single trunk accent trees. Multi-trunk trees shall have 5 feet clear trunk. Trees within the clear sight zones of intersections shall be maintained with a clear trunk of 8 ½ feet. Shrubs/ground cover within the clear site zones at intersections shall be maintained at a height no greater than 24 inches. In addition, Contractor shall remove all palm tree flower stalks and any broken palm fronds as required. Prune all plants as necessary to maintain proper form, health and vigor.
- H. WEEDING AND MULCHING: Weeds will be removed from flower and planting beds by hand once per month including grass and weeds from cracks in sidewalks and parking lots. An herbicide spray such as "Round Up" may be used on paved areas.

In addition, pine straw mulch shall be replaced as needed to maintain proper thickness in all bedding areas in the Spring and Fall. Mulching is to be performed around agreed upon dates with the City's point of contact. The designated times to apply mulch may be adjusted according to the conditions of the existing mulch. Mulching is to be performed two times annually and spread to one and one half $(1 \frac{1}{2})$ inches thick. Only the areas where the mulch is very thin are to be mulched. Mulching is to be completed in seven (7) working days after commencing.

At all trees outside of a plant bed (if applicable), a 6-foot diameter ring of pine straw mulch shall be maintained; at all shrubs outside of a planting bed (if applicable), a 4-foot diameter ring of pine straw mulch shall be maintained; and in all planting beds, pine straw mulch shall be maintained continually.

I. IRRIGATION: Existing irrigation shall be closely monitored to ensure efficient complete and appropriate watering of all landscape grass, plants and trees. Watering shall be applied during early morning. The Contractor shall be responsible for performing minor adjustments and services such as: flow control, radius adjustment, nozzle cleaning, sprinkler height, and level adjustment as a part of this contract. The Contractor shall monitor equipment for breakage, foreign materials, wear, proper coverage and electrical failure. Maintain the irrigation system (if applicable).

The Owner will reimburse the Contractor's actual, out-of-pocket irrigation repair material costs, documented with appropriate back-up original invoices from the supplier; Contractor must obtain Owner's written approval prior to incurring any material costs for any repairs. Any plant, tree, palm, or turf that dies from inadequate or excessive irrigation is to be replaced at the Contractor's expense.

The Contractor shall be responsible for performing a complete irrigation evaluation at commencement of the Contract and monthly thereafter. The Contractor shall be required to furnish the City of Panama City Beach's point of contact with a summary report of each clock and zone operation after each inspection. Contractor shall furnish recommendation for repair and improvements to the systems with an itemized cost for proposed work. Irrigation clocks shall have each zone identified within thirty (30) days of commencement of contract.

The Contractor is responsible for adjusting the irrigation as needed and turning off the irrigation before any freezes and turning it back on when the weather is appropriate.

J. FERTILIZATION: All shrubs, trees and palms located at all areas shall be fertilized twice a year with an Owner approved 10-10-10 fertilizer or better with three different types of nitrogen. The proper rate of application shall be determined by the size of the shrubs, trees and palms.

In addition, all turf areas shall be fertilized twice a year with an Owner approved 10-10-10 or better fertilizer with three different types of nitrogen at the rate of ten (10) pounds per thousand square feet. All fertilizers shall be kept out of ditches and storm water retention ponds and immediately removed from sidewalks and roadways. Fertilizing shall be completed within five (5) working days after commencement.

In the event that additional fertilizer applications are required the Owner will reimburse the Contractor's actual, out-of-pocket material costs for the fertilizer, documented with appropriate back-up original invoices from the supplier; Contractor will be compensated at the hourly rate agreed upon in the 00030 Bid Proposal Form. Contractor must obtain Owner's written approval prior to incurring any material costs.

K. pH ADJUSTMENT: If needed Contractor is responsible for adjusting improper pH by applying up to 50 pounds per 100 square feet of lime or up to 10 pounds of sulfur per 1000 square feet.

- L. STAKING: Staked trees and trees that need additional training shall be re-staked and adjusted as often as necessary. Stakes shall be adjusted and/or removed when deemed appropriate by Contractor. However, trees that need to be re-staked utilizing specialized equipment and crews shall be done at a mutually agreed upon price, submitted in writing for review and approval.
- M. DISPOSAL: Excessive grass cuttings, edging material, tree and shrub trimmings, weeds, leaves, and other debris shall be blown, raked and removed from grassed areas, sidewalks, streets, parking areas, shrub and planting beds.

All debris shall be legally disposed of off-site, in accordance with all applicable laws, rules and regulations, and shall not be allowed to remain overnight.

N. DAMAGE: Grassed areas, trees or shrubs killed or damaged as a result of Contractor's actions (or the actions of anyone for whom Contractor is responsible) shall be repaired to original condition or replaced by the Contractor at no cost to the Owner.

In the event of any damage or deterioration of a site by natural or other causes, Contractor shall promptly notify the Owner, in its sole discretion, may accept, a proposal to repair or remedy any such problem, including repair to the irrigation system and its timers, and replacement of any foliage, trees, shrubbery, bedding plants, etc. (This includes auto accidents and fire accidents)

O. SAFETY: The Contractor and all personnel shall abide by all safety regulations while performing any work on the landscaped sites.

All personnel shall wear safety vests; safety flags and signs shall be placed at proper locations along the right-of-way, and flashing yellow lights shall be on vehicles and other moving motorized equipment.

All safety equipment is to be furnished by the Contractor. All safety equipment shall be of the type approved by the Florida Department of Transportation. Failure to comply with all safety regulations could result in work being stopped until compliance is in effect.

PRICING: BID PROPOSAL FORM

The Contractor is required to bid:

- A. A total lump sum bid for all sites.
- B. An Additional Work Unit Cost for the maintenance of additional work, subject to Contractor's availability;

Pricing Documentation: To verify that pricing remains compliant with the contract terms, the successful bidder shall be prepared to provide backup data such as labor timesheets, purchase receipts for part, etc. on demand. All invoices shall include a brief written job summary describing the repair, parts used, fees incurred, etc. so that City personnel may review/analyze the work completed for future planning, budgeting, and scheduling purposes.

DEFECTIVE WORK

All work completed by the Contractor at any time during the progress of the work shall be subject to the inspection by the City, who shall have full power to accept or reject any part thereof.

The contractor shall remedy any defective or unsatisfactory work at no additional cost to the City. In the event the Contractor fails to initiate corrections within 48-hours after written notice, the City shall have full right to have same done and to bill Contractor for cost thereof.

TERMS OF CONTRACT

- A. Payment will be made 30 days after satisfactory delivery and inspection of the services provided. The City shall determine the quality and acceptability of the services prior to payment. The City shall decide finally and conclusively any differences that may arise as to the interpretation of the specifications or the fulfillment of the terms of the Contract.
- B. Once accepted, all proposed pricing shall be firm and be valid for a period of twelve (12) months.
- C. Agreement is for two (2) years with two (2) one-year options at the mutual agreement of both parties.

OTHER CONSIDERATIONS FOR SCOPE OF WORK:

- a. The successful bidder shall supervise and direct the work, using skillful labor and proper equipment for all tasks. Safety of the bidder's personnel and equipment shall be the responsibility of the bidder.
- b. <u>OSHA</u> Precautions shall be exercised at all times for the protection of persons and property. Bidder shall conform to all OSHA, State and County regulations while performing under the terms and conditions of this contract. Any fines levied by the above-mentioned authorities because of inadequacies to comply with these requirements shall be borne solely by the bidder responsible for the same.
- c. <u>Licenses</u> The bidder must be duly licensed in accordance with the State's statutory requirements to perform the work identified herein. Proof of licensure shall be submitted with the bids. Required licenses shall be maintained and valid throughout the term of the contract.
- d. <u>Permits</u> Bidder is responsible for obtaining any necessary State contractor's licenses and local business tax receipts (BTR).
- e. <u>Damage to Property</u> The bidder shall use every method at their disposal to protect all properties they are working on/around. If the City project manager finds unnecessary damage to properties (public or private), the City shall invoke its authority to immediately terminate the contract and pay the bidder for work completed to date. The termination shall be effective <u>immediately</u> upon written notice by the City to the bidder.

The bidder will take care, and assume responsibility for any damage caused:

a. The bidder shall assume full responsibility for any damage to any work areas or to the City, or of any adjacent lands or areas, resulting from the performance of the work on City property/easements. The bidder shall be responsible for repairing or replacing property to the satisfaction of the City which is damaged by the bidder.

- b. Should any claim be made by any such owner or occupant because of accident, intentional act, the performance of the work, or for any other such reason the cause of which is the bidder or its subcontractors, agents or employees, the bidder shall promptly settle such dispute by negotiation or otherwise resolve the claim by arbitration or other dispute resolutions proceeding or at law.
- f. <u>Storage of Bidder's Equipment</u> The bidder shall be responsible for locating areas in which to store their equipment. Such areas shall not be located within the City parking lot if services are being performed during business hours.
- g. <u>Violations</u> The bidder shall be responsible for taking corrective action in response to any notices of violations issued as a result of the bidder's or any Subcontractor's actions or operations during the performance of this contract. Corrections of any such violations shall be at no additional cost to the City.
- h. <u>Additional Work</u> The City shall retain the option to add or remove work areas if it deems necessary.

- 5. All employees hired by Contractor/Vendor on or after January 1, 2021, have had their work authorization status verified through the E-Verify system.
- 6. The City may terminate this contract on the good faith belief that the Contract or its Subcontractors knowingly violated Florida Statues 448.09(1) or 448.095(2)(c).
- 7. If this Contract is terminated pursuant to Florida Statute 448.095(2)(c), the Contractor/Vendor may not be awarded a public contract for at least one year after the date on which this Contract was terminated.
- 8. The Contractor/Vendor is liable for any additional cost incurred by the City as a result of the termination of this Contract.

Under U.S. law, this student will become a resident alien for tax purposes if his or her stay in the United States exceeds 5 calendar years. However, paragraph 2 of the first Protocol to the U.S.-China treaty (dated April 30, 1984) allows the provisions of Article 20 to continue to apply even after the Chinese student who qualifies for this exception (under paragraph 2 of the first protocol) and is relying on this exception to claim an exemption from tax on his or her scholarship or fellowship income would attach to Form W-9 a statement that includes the information described above to support that exemption.

Backup Withholding

What is backup withholding? Persons making certain payments to you must under certain conditions withhold and pay to the IRS 24% of such payments. This is called "backup withholding." Payments that may be subject to backup withholding include interest, tax-exempt interest, dividends, broker and barter exchange transactions, rents, royalties, nonemployee pay, payments made in settlement of payment card and third party network transactions, and certain payments from fishing boat operators. Real estate transactions are not subject to backup withholding.

"Project" means the project subject of the Subcontract/Purchase Order.

"Scope" means the scope of work to be provided by the Subcontractor under the Contract or the Goods and Services to be supplied and performed by Seller under the Purchase Order, as applicable.

"State" means a state of the United States or the District of Columbia or the Commonwealth of Puerto Rico, as applicable

"Alternate/ Leased Employer Endorsement" is an endorsement added to a workers compensation policy that provides an entity scheduled as an alternate employer with primary workers compensation and employers liability coverage as if it were an insured under the policy. This endorsement is commonly used when a temporary help agency (the insured) is required by its customer (the alternate employer) to protect the alternate employer from claims brought by the insured's employees.

SECTION 2: STANDARD INSURANCE COVERAGES

Successful Bidder' shall comply with the following:

- 1. Unless higher limits or additional coverages are required by the Contract/Purchase Order or Owner Contract, the Successful Bidder' shall secure and maintain the minimum from the earlier commencement of work or the effective date of the Contract/Purchase Order insurance coverages and limits required by this Exhibit A.
- 2. Failure of the Contractor/Buyer to identify deficiencies in any insurance provided by Successful Bidder' shall not relieve Successful Bidder' from any insurance obligations. Required coverages are as follows:

2.1. Commercial General Liability Insurance Coverages:

Commercial General Liability insurance using ISO's CG 00 01 or its substantial equivalent with **City of Panama City Beach** as an additional insured using <u>ISO's CG 20 10</u> or its substantial equivalent for <u>ongoing operations</u> and ISO's CG 20 37 or its substantial equivalent for <u>completed operations</u> with the following minimum limits:

- \$1,000,000 Each Occurrence
- \$1,000,000 Personal and Advertising Injury
- \$2,000,000 General Aggregate
- \$2,000,000 Products-Completed Operations Limit
- \$500,000 Damage to Rented Premises

Per Project using ISO's CG 25 04 or its substantial equivalent

The Successful Bidder' must disclose to **City of Panama City Beach** any endorsements that limit or exclude coverage customarily provided by ISO's CG 00 01.

The Successful Bidder''s Commercial General Liability policy shall not contain an exclusion or restriction of coverage for the following:

- 1. Claims by one insured against another insured, if the exclusion or restriction is based solely on the fact that the claimant is an insured, and there would otherwise be coverage for the claim.
- 2. Claims for property damage to the Successful Bidder"s Work arising out of the products-completed operations hazard where a Subcontractor performed the damaged Work or the Work out of which the damage occurs.
- 3. Claims for bodily injury other than to employees of the insured.
- 4. Claims for indemnity arising out of injury to employees of the insured.
- 5. Claims or loss excluded under a prior work endorsement or other similar exclusionary language.
- 6. Claims or loss due to physical damage under a prior injury endorsement or similar exclusionary language.
- 7. Claims related to residential, multi-family, or other habitational projects if the work is to be performed on such a project.
- 8. Claims related to roofing, if the work involves roofing.
- 9. Claims related to exterior insulation finish systems (EIFS), synthetic stucco, or similar exterior coatings or surfaces if the work involves such coatings or surfaces.
- 10. Claims related to earth subsidence or movement, where the work involves such hazards.
- 11. Claims related to explosion, collapse, and underground hazards, where the work involves such hazards.

The Successful Bidder's Commercial General Liability insurance will remain in force with annual policy periods for the period of the statute of repose applicable to this project. *Alternatively, suppose a "project-specific" General Liability policy is used to satisfy these requirements. In that case, it must be endorsed to provide extended completed operations for the period of the statute of repose applicable to this project.*

2.2. Workers Compensation

Worker's Compensation Insurance and Employer's Liability Insurance (including occupational disease) to cover statutory benefits and limits under the Worker's Compensation laws of any applicable jurisdiction in which the Scope is to be performed and minimum limits.

- Bodily Injury by Accident \$100,000 Each Accident
- Bodily Injury by Disease \$500,000 Policy Limit
- Bodily Injury by Disease \$100,000 Each Employee

Policy coverage terms and conditions to include:

- USL&H where applicable.
- Jones Act where applicable.
- All State's endorsement where applicable.
- Employers Liability/Stop Gap Liability if work is performed in Washington, Wyoming, Ohio, North Dakota, or the Commonwealth of Puerto Rico.

- For the attainment of Workers Compensation in monopolistic states and Puerto Rico, coverage must be secured through the state fund of that State.
- The certificate must identify that coverage applies in the State where the Project is located.

2.3. Automobile Liability

Commercial Automobile Liability insurance covers all owned, leased, and non-owned vehicles used in connection with the Scope. Business Auto Coverage Form using ISO's CA 00 01 or its substantial equivalent including liability coverage for all autos owned (Symbol 1), rented, hired, or borrowed by the contractors, as well as liability coverage for mobile equipment subject to compulsory insurance or financial responsibility laws or other motor vehicle insurance laws with the following minimum limit:

\$1,000,000 – Any One Accident – Combined Single Limit

Suppose the Contractor/Sub-Contractor/Vendor is responsible for removing any pollutants from a site. In that case, the Successful Bidder' will need to cover its automobile exposure for transporting the pollutants from the site to an approved disposal site. Therefore, auto liability coverage should be endorsed to include the required auto pollution endorsements and Motor Carrier Act Endorsement, MCS 90, and the ISO Form CA 9948 (Pollution Liability Broadened Coverage for Business Automobile).

2.4. Umbrella or Excess Liability Required: Yes

Also, the Successful Bidder' shall provide an umbrella or excess liability insurance providing in excess of the underlying Commercial General Liability, Business Automobile Liability, Pollution Liability (if required), and Employers' Liability insurance above, with the following minimum limits:

- \$1,000,000 Each Occurrence
- \$1,000,000 Annual Aggregate (where applicable in the underlying)

Such umbrella or excess liability policy shall provide substantially the same coverage as the underlying Commercial General Liability (including **City of Panama City Beach** as additional insured), Business Automobile Liability, Pollution Liability, and Employers' Liability insurance. In addition, it shall expressly provide that the umbrella or excess policy will drop down over the underlying insurance's reduced or exhausted aggregate limit. The umbrella or excess policy shall also be primary insurance to **City of Panama City Beach** (including primary insurance to **City of Panama City Beach**'s own Commercial General Liability and Umbrella policies), and Successful Bidder's umbrella insurer agrees not to seek contribution from **City of Panama City Beach** insurance.

2.5. Professional Liability Required: No

Professional Liability Insurance is required to cover liability for claims that arise from the errors, omissions, or acts of the Successful Bidder' or any entity the Successful Bidder' is legally responsible in the provision of professional services. The policy shall be primary and non-contributory, with the insuring agreement to read: "to pay on behalf of" and shall be effective (retroactively, if applicable) from the commencement date of all professional activities in connection with the Scope. The coverage shall be maintained for three years following the final acceptance of the Project.

Minimum limits are:

- Prime Design Professional: Choose limits when required per claim/annual aggregate;
- Sub-Design Professional: Choose limits when required per claim/annual aggregate.

Upon request, a copy of the policy shall be provided to **City of Panama City Beach**. Coverages shall not include any exclusions or other limitations related to the scope of the services, delays in project completion, or cost overruns.

For Professional Liability Insurance, the term "Prime Design Professional" means the architect and/or engineer providing architectural, engineering, and/or other professional services under a contract directly with our company. The term "Sub-Design Professional" means any architect and/or engineer providing architectural, engineering, and/or other professional services directly or indirectly to a Prime Design Professional in connection with the project. A Prime Design Professional is also a Contractor/Subcontractor, and a Sub-Design Professional is also a Sub-subcontractor.

2.6 Riggers Liability Required: No

If marked as required, the Scope involves the rigging, hoisting, lowering, raising, or moving of property or equipment belonging to others. Riggers Liability Insurance is required to insure against physical loss or damage to the property or equipment.

2.8 Aircraft/Watercraft: Required: No

If marked as required, the Scope involves using any owned, leased, chartered, or hired aircraft or watercraft of any type. As applicable, Aircraft Liability Insurance or Watercraft Liability Insurances required in an amount of not less than **Choose limits when required** per occurrence, including Passenger Liability for bodily injury and property damage.

2.9 Property Insurance:

Property Insurance coverage for tools and equipment owned, leased, or used by the Subcontractor/Seller in the performance of the Scope. The Property Insurance shall extend to equipment, materials, and supplies stored off the Project site or in transit to the Project site to be furnished as part of the Scope and incorporated into the Project.

2.9.1 Herbicide & Pesticide Application Insurance: Required: Yes

Successful Bidder' shall secure and maintain the minimum Herbicide & Pesticide Application Insurance coverage and limits required by this Exhibit A from the effective date of the Contract/Purchase Order until the end of the applicable warranty period. The policy shall be submitted to the Contractor/Buyer for review and approval before commencement of the Scope. Failure of the Contractor/Buyer to identify deficiencies in the Herbicide & Pesticide Application Insurance provided by Subcontractor/Vendor shall not relieve Subcontractor/Vendor from any obligations.

Minimum limits are: Including Cleanup Cost

- \$1,000,000.00 per occurrence or claim
- \$2,000,000.00 **policy aggregate.**

The coverage shall be as follows: Subcontractor shall provide Herbicide & Pesticide Application Insurance. If the policy contains a general aggregate, this aggregate must apply on a per-project basis and shall be evidenced on Subcontractor's/Vendors Certificate of Insurance. The limits shall not be subject to reduction as to the Contractor/Buyer or Owner because of any claim asserted against the Subcontractor/Vendor other than in connection with the Scope. Instead of indemnifying, the policy must read "to pay on behalf of." In addition, the following coverages must be included: (1) Completed Operations (five (5) year continuation beyond completion of the Scope); (2) Broad Form Contractual and Independent Contractors (including coverage for third party over claims); (3) On-Site, Off-Site and In-Transit exposures; and (4) Loading and Unloading. Exclusions or restrictions pertaining to mold and EIFS are not permitted. The coverage may be written on an "occurrence" or "claims made" basis. If written on a "claims made" basis, the retroactive date must be included to coincide with the effective date of the Subcontract/Purchase Order, and an extended reporting period (three (3) years minimum) must be included.

The coverage may be written on an "occurrence" or "claims made" basis. If written on a "claims made" basis, the retroactive date must be included to coincide with the effective date of the Subcontract/Purchase Order, and an extended reporting period (three (3) years minimum) must be included.

Deductibles/Denial of Claims:

Contractor/Vendor shall be responsible, at no additional cost to Contractor/Buyer, for the payment of any deductibles or self-insured retention in connection with the insurance coverages required by this Exhibit A both for itself and all Additional Insureds. Any self-insured retention or deductible in excess of \$25,000 must be declared when Subcontractor/Seller submits its bid and must be approved explicitly by Contractor/Buyer before executing the Subcontract/Purchase Order. Subcontractor/Seller shall be responsible for any loss arising from coverage denial by its insurance carrier.

Leased Successful Bidder' Employee Liability

If the leases one or more employees through the use of a payroll, employee management, or other company, the Successful Bidder' must directly procure workers compensation/employer's liability insurance. The insurance shall be written on a "Minimum Premium" or "If Any" policy form.

In addition, the worker's compensation/employer's liability coverage provided to and for the leased employees by the payroll, employee management, or other company must be evidenced and include an <u>Alternate / Leased</u> <u>Employer Endorsement</u> or its substantial equivalent WC endorsement for that State, naming Successful Bidder' as the alternate employer.

Insurer Requirements

Each insurer providing insurance coverage as required by this contract shall be a licensed admitted insurer authorized to issue such coverages in each State in which any part of the Scope is performed. The insurer shall be acceptable to **City of Panama City Beach** and have an AM Best rating of "A-" or better.

Before accepting the Contractor/Sub-Contractor/Vendor's bid, City of Panama City Beach reserves the right to require more significant limits based on the nature of the operations performed by the Successful Bidder'.

Certificate of Insurance

Before commencing its performance and throughout the warranty period under the Contract /Purchase Order, the Successful Bidder' shall provide **City of Panama City Beach** a current certificate of insurance evidencing the coverages required by this contract (a sample Certificate of Insurance is attached for reference purposes).

Sub-subcontractor/Sub-Vendor

Before permitting any lower tier Sub-subcontractor/Sub-vendor to perform Scope under the Contract/Purchase Order, the Successful Bidder' shall require its sub-subcontractor/Sub-vendor to maintain insurance in like form and amounts to that required herein. Successful Bidder' shall be responsible for ensuring that it's sub-subcontractor/Sub-vendor maintains insurance in like form and amounts and shall provide evidence of same to **City of Panama City Beach** if requested.

Any subcontractors engaged by the Contractor shall comply with the above requirements. Consideration for specific trades can be made with prior approval.

Notice of Cancellation

All insurance coverages required by this contract shall contain a provision that the coverage afforded hereunder cannot be canceled, non-renewed, allowed to lapse, or have any restricted modifications added unless at least thirty 45) days prior written notice has been given to **City of Panama City Beach**

Additional Insureds

All insurance required by this contract (<u>excluding only Workers Compensation Insurance and Professional Liability</u> <u>Insurance</u>) shall name the City of Panama City Beach and its officials, employees, and volunteers as Additional Insureds and any other parties as required by the Owner Contract, and shall be primary and non-contributory to any insurance maintained by Indemnified Parties and Additional Insureds and any other parties as required by Owner Contract, all of which shall be stated on the Certificate of Insurance provided by the Successful Bidder'.

The General Liability Additional Insured Endorsement shall use ISO's or CG 2010 or its substantial equivalent for ongoing operations and ISO's CG 20 37 or its substantial equivalent for completed operations. By endorsement or policy language, evidence of Additional Insured and Primary and Non-Contributory coverage must be provided with the certificate of insurance for General Liability. The Successful Bidder's insurers will provide insurance to **City of Panama City Beach**, on a primary basis and agree not to seek contribution from insurance by using ISO's CG 20 01 or its substantial equivalent. Successful Bidder's insurers also agree to waive rights of subrogation against **City of Panama City Beach** using ISO's CG 24 04 or its substantial equivalent.

Waiver of Subrogation

All insurance coverages maintained by Successful Bidder' shall include a waiver of any right of subrogation of the insurers thereunder against Indemnified Parties and Additional Insureds and all of their respective assigns, subsidiaries, affiliates, employees, insurers, and underwriters, and of any right of the insurers to any set-off or counterclaim or any other deduction, whether by attachment or otherwise, in respect of any liability of any person insured under any such policy (Workers Compensation – where permitted).

The Successful Bidder' further waives all claims and all rights of subrogation against Indemnified Parties' and Additional Insureds' other contractors and all of their respective assigns, subsidiaries, affiliates, employees, insurers, and underwriters for loss of, or damage to, contractors Scope, tools, machinery, equipment, material, supplies, or any other losses within the scope of any insurance maintained by **City of Panama City Beach**. If any of the Indemnified Parties and Additional Insureds are partially or wholly self-insured, then the waiver of subrogation shall apply as if their insurance covered them.

Insurance Policy Review/Exclusions/Copies

City of Panama City Beach, can receive copies of all insurance policies upon request. Policies shall not contain any exclusions that are unacceptable to **City of Panama City Beach**. If requested by **City of Panama City Beach**, all insurance carriers must certify all policies as accurate and complete. At their sole discretion, policies shall not contain any unacceptable exclusions to **City of Panama City Beach**. **City of Panama City Beach** 's right to review and approve all insurance policies will not constitute a waiver of any rights created by or provisions contained in this contract should they differ from those contained in such policies.

Claims-Made Policies

Except for Professional Liability Insurance, claims-made policies are not acceptable.

Effect of Specified Coverages

The Insurance obligations under this agreement shall be 1—all the Insurance coverage and/or limits carried by or available to the Contractor; or 2—the minimum Insurance coverage requirements and/or limits shown in this agreement, whichever is greater. Any insurance proceeds in excess of or broader than the minimum required coverage and/or minimum required limits, which apply to a given loss, shall be available to **City of Panama City Beach**. No representation is made that this agreement's minimum insurance requirements are sufficient to cover the Contractor's obligations under this agreement.

Breach of Insurance Requirements

Successful Bidder''s failure to obtain and maintain insurance coverages as required by this Exhibit A or any other Exhibit or attachment shall constitute a material breach of the Contract/Purchase Order. In such event, in addition to any other rights and remedies contained in the Contract/Purchase Order, (i) **City of Panama City Beach** may, at its option, terminate the contract for default; (ii) **City of Panama City Beach** may, at its option, purchase such coverage and back charge the premium and associated costs to Successful Bidder'; and/or (iii) any of the Indemnified Parties, or Additional Insureds can require, that contractor and/or its subcontractors to pay for all attorney's fees, expenses, and liability as a result of any claim or lawsuit for which coverage would have been provided to the Indemnified Parties or Additional Insureds under contractors insurance program but for a breach by Contractor or any of its subcontractors.

Furthermore, to the extent of their respective interests, the Insurers of those entities that were to be included as Additional Insureds are deemed third-party beneficiaries of the insurance procurement obligation and have the same rights against the breaching party as the Indemnified Parties or Additional Insureds.

If any of the preceding insurance coverages are required to remain in force after final payment and are reasonably available, an additional certificate evidencing continuation of such coverage shall be submitted with the final application for payment as required. If the insurer does not furnish any information concerning the reduction of coverage, it shall be furnished by the contract with reasonable promptness according to the Successful Bidder' 's information and belief. Suppose Successful Bidder' fails to maintain insurance.**City of Panama City Beach** may (at its sole option) terminate the Successful Bidder' or place such insurance and deduct any cost, fees, and related expenses from Successful Bidder' pay request.

Any Successful Bidder' engaged by the Contractor shall comply with the above requirements. Consideration for specific trades can be made with prior approval.

LANDSCAPING MAINTENANCE SERVICES

THIS LANDSCAPING MAINTENANCE SERVICES CITY MAIN CAMPUS FY2024 AGREEMENT is made and entered into this _____ day of _____, 2024, by and between the CITY OF PANAMA CITY BEACH, FLORIDA, a municipal corporation (City) and _____ (Contractor).

PREMISES

1. SCOPE OF WORK

Contractor will provide annual Landscape Maintenance Services, as more particularly described in the Specifications listed in Invitation to Bid number PCB24-12.

If the Contractor believes that any particular service is not within the scope of the contract, is a material change, or will otherwise require more compensation to the Contractor, the Contractor must immediately notify the City's Representative in writing of this belief. If the City's Representative believes that the particular service is within the scope of the contract as written, the Contractor will be ordered to and shall continue to supply the service as changed and at the cost stated for the work/service within the scope. The Contractor must assert its right to an adjustment under this clause within thirty (30) days from the date of the receipt of this agreement.

2. COMPENSATION

As compensation for supplying the services contemplated herein and performance rendered by the Contractor of its duties and obligations hereunder, City shall pay Contractor according to the not to exceed bid unit prices submitted on PCB24-12 ITB LANDSCAPING MAINTENANCE SERVICES CITY MAIN CAMPUS. The City shall pay to the Contractor as full consideration for the services required by this Agreement, at the UNIT PRICE contained in the Contractor's cost proposal, upon the basis of actual measured quantities as the same may be finally determined by the City Manager or his/her designee(s).

A. Extra and/or Additional Work Changes – Should City at any time during the progress of said work request alterations, deviations, additions, or omissions from said specifications or other contract documents, it shall be at liberty to do so by written authorization to Contractor, and the same shall in no way affect or make void the Agreement. The unit price of any such addition or deletion from the contract Bid price, must be mutually agreed upon by both parties.

3. PAYMENT

Contractor will invoice for payment to the City when satisfactory inspection of requested/scheduled WORK has been completed. The invoice(s) shall be delivered to accounts payable at City Hall, 17007 Panama City Beach Parkway, Panama City Beach, Florida 32413. Payment to Contractor shall be made via ACH or Virtual Credit Card.

4. TERM

Unless terminated sooner pursuant to the provision of the Termination clauses contained in paragraph 6, and subject to the availability of funds appropriated for this purpose, this Agreement shall take effect on the executed date of award and be valid for a period of one (2) years with an option to renew for two (2) additional one (1) year terms.

5. PRICE ADJUSTMENTS

- A. <u>Increases</u> After the first year of the contract, Contractor may request a price increase adjustment no more than two times in any following contract year. In the event Contractor desires to increase price, City must be notified immediately. Price increases must be approved by City and no payment for additional materials or services, beyond the amount stipulated in the Contract shall be paid without prior approval. All price increases must be supported by Producer Price Index or manufacturer documentation and justification. Contractor must honor previous prices for thirty (30) days after approval and written notification from City. It is the Contractor's responsibility to keep all pricing up to date and on file with City. All price changes must be provided to City using the same format as was provided and accepted in the Contractor's proposal.
- B. <u>Reductions</u> Price reductions may be offered at any time during Contract. City may request a price reduction, which Contractor shall permit, when such a request is supported by Producer Price Index.

6. TERMINATION OF CONTRACT

- A. City Termination for Cause The Agreement may be terminated by the City for cause in the event of any breach hereof, including, but not limited to, Contractor's: (1) failing to carry forward and complete the Work as provided herein; (2) failing to comply with applicable laws, regulations, permits, or ordinances; (3) failing to timely correct defective Work; (4) making a general assignment for the benefit of its creditors; (5) having a receiver appointed because of insolvency; (6) filing bankruptcy or having a petition for involuntary bankruptcy filed against it; (7) failing to make payments when due to subcontractors, vendors, or others for materials or labor used in the Work; (8) making a material misrepresentation to the City regarding the Work; (9) arrest or conviction of felony or fraud, or (10) any other material breach of this Agreement. In such event, the City shall provide Contractor with written notice of its intention to terminate this Agreement, stating the nature of the deficiency and the effective date of termination. At the City's sole judgement and discretion, the City may afford Contractor an opportunity to cure said deficiency, in which event the notice shall specify the time allowed. Upon termination, the City may take possession of the premises and of all materials thereon and finish the Work by whatever means it seems expedient.
- B. <u>City Termination for Convenience</u> Notwithstanding any other provision hereof, the City may at any time terminate this Agreement or any Work

issued under it, in whole or in part, without cause, upon thirty (30) days advanced written notice to Contractor. In such event, Contractor shall be compensated for any Work performed prior to the date of termination and for materials that were ordered prior to receipt of notice of termination that cannot be returned to the vendor, which shall become City property. Upon receipt of notice, Contractor shall discontinue Work on the date and to the extent specified therein and shall place no further orders for materials, equipment, services, or facilities, except as needed to continue any portion of the Work not terminated. Contractor shall also make every reasonable effort to cancel, upon terms satisfactory to the City, all orders or subcontracts related to the terminated Work. Contractor may not claim any compensation not specifically provided herein, including, but not limited to loss of anticipated profits, idle equipment, labor, and facilities; or any additional claims of subcontractors and vendors.

7. COMPLIANCE WITH LAWS

The Contractor shall be responsible to know and to apply all applicable federal and state laws, all local laws, ordinances, rules, regulations, and all orders and decrees of bodies or tribunals having jurisdiction or authority which in any manner affect the work, or which in any way affect the conduct of the work. Contractor shall always observe and comply with all such laws, ordinances, rules, regulations, orders, and decrees. The Contractor shall protect and indemnify the City of Panama City Beach and all its officers, agents, servants, or employees against any claim or liability arising from or based on the violation of any such law, ordinance, rule, regulation, order, or decree caused or committed by Contractor, its representatives, sub-contractors, sub-consultants, professional associates, agents, servants, or employees. Additionally, Contractor shall obtain and maintain at its own expense all licenses and permits to conduct business pursuant to this contract from the federal government, State of Florida, Bay County, or municipalities when legally required, and maintain same in full force and effect during term of the contract.

8. WARRANTY

The Contractor agrees that, unless otherwise specified in the specifications of the invitation to bid, the service furnished as a result of this invitation and award thereto shall be covered by the most favorable commercial warranty the Contractor gives to any customer for comparable services and that the right and remedies provided herein are in addition to and do not limit any rights afforded to the City by any other provision of the invitation/offer.

9. INSURANCE AND INDEMNIFICATION

Contractor shall at its own expense maintain in force during the term of the contract the insurance on policies and insurers acceptable to the City as required by the City's Insurance Requirements as specified in the Required Documents section of the solicitaiton.

i. Within thirty (30) days of the date of the Award, and thereafter upon the written request of the City, Contractor shall furnish to the City such certificates of coverage and certified copies of policies pursuant to the City's

Insurance requirements in order to satisfy this provision, the documentation required by this part must be sent to the following address: <u>ATTN: RISK</u> <u>MANAGEMENT DIRECTOR, 17007 Panama City Beach Parkway, Panama City Beach, Florida 32413.</u>

ii. Regardless of the coverage provided by any insurance, the successful Contractor shall indemnify, save harmless and defend the City, its agents, servants, or employees from and against any and all claims, liability, losses and/or causes of action which may arise from any negligent act or omission of the successful Contractor, its sub-contractors, agents, servants, or employees during the course of performing services or caused by the goods provided pursuant to these Bid documents and/or resultant contract.

If any third-party claim is made against the City that, if sustained, would give rise to indemnification liability of the Contractor under this Agreement, the City shall promptly cause notice of the claim to be delivered to the successful Contractor and shall afford the Contractor and its counsel, at the Contractor's/Vendor's sole expense, the opportunity to join in defending or compromising the claim. The covenants contained in this paragraph shall survive the termination of this Agreement.

10. ATTORNEY'S FEES

In the event of any litigation hereunder, each party shall be responsible for its own attorney's fees and court costs at all trial and appellate levels and at any mediation or arbitration.

11. TIME

Time is of the essence in this Agreement.

12. FORCE MAJEURE

The Contractor's failure or inability to perform the stated scope of work at any time as a result of circumstances beyond its control, such as, but not limited to, war, terrorism, strikes, fires, floods, hurricanes, acts of God, power failures, or damage or destruction of any facility related thereto, shall not be deemed a breach of this Agreement.

13. **REMEDIES**

In the event of failure of the Contractor to deliver product in accordance with the contract terms and conditions, the City, after due written notice, may procure the products from other sources and hold the Contractor responsible for any resulting additional purchase and administrative costs. This remedy shall be in addition to any other remedies that the City may have. Failure to cure a breach of a material term hereunder within 24-hours of Contractor's receipt of written notice thereof shall entitle the City to terminate this Agreement. All rights and remedies conferred upon the parties in this Agreement shall be cumulative and in addition to those available under the laws of the State of Florida.

14. ASSIGNMENT

This Agreement may be assigned with the consent of the City Council.

15. SEVERABILITY

In the event any provision of this Agreement shall be held invalid or unenforceable by any court of competent jurisdiction, such holding shall not invalidate or render unenforceable any other provision hereof.

16. CHOICE OF LAW & VENUE

This Agreement shall be governed by the laws of the State of Florida. Any legal proceeding regarding this Agreement shall be brought in the 14th Judicial Circuit in Bay County, Florida.

17. MODIFICATIONS

No modification, amendment, or alteration in the terms or conditions contained herein shall be effective unless contained in a written document prepared with the same or similar formality as this Agreement and executed by the City and Contractor.

18. WAIVER

Failure by the City to enforce any provision of this Agreement shall not be deemed a waiver of the provision or modification of this Agreement. A waiver by the City of any breach of a provision of this Agreement shall not be deemed a waiver of any subsequent breach and shall not be construed to be a modification of the terms and conditions of this Agreement.

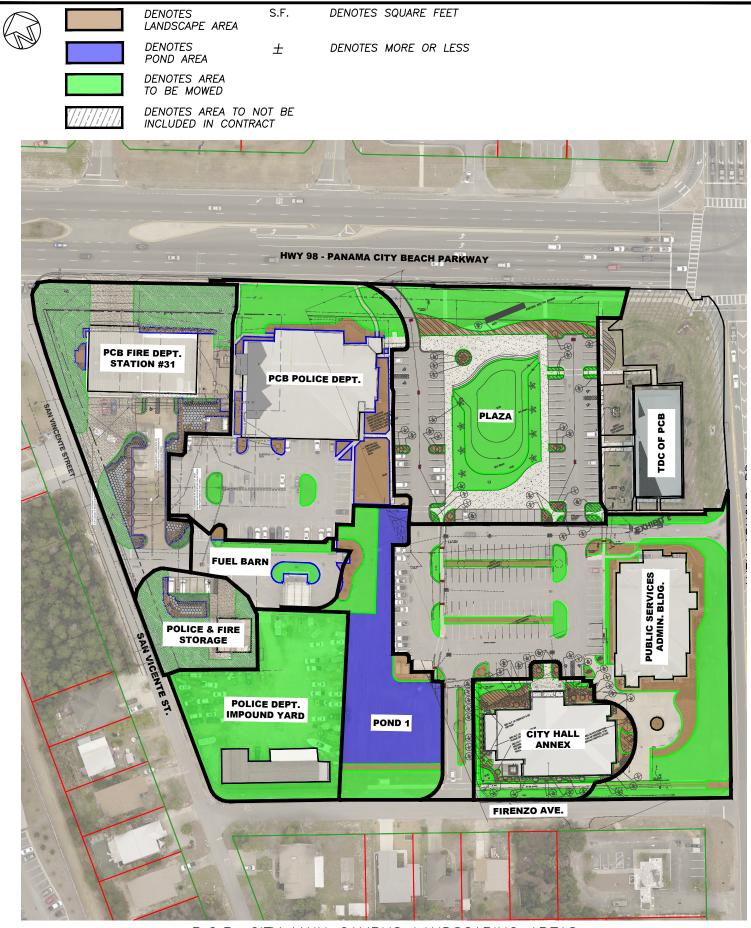

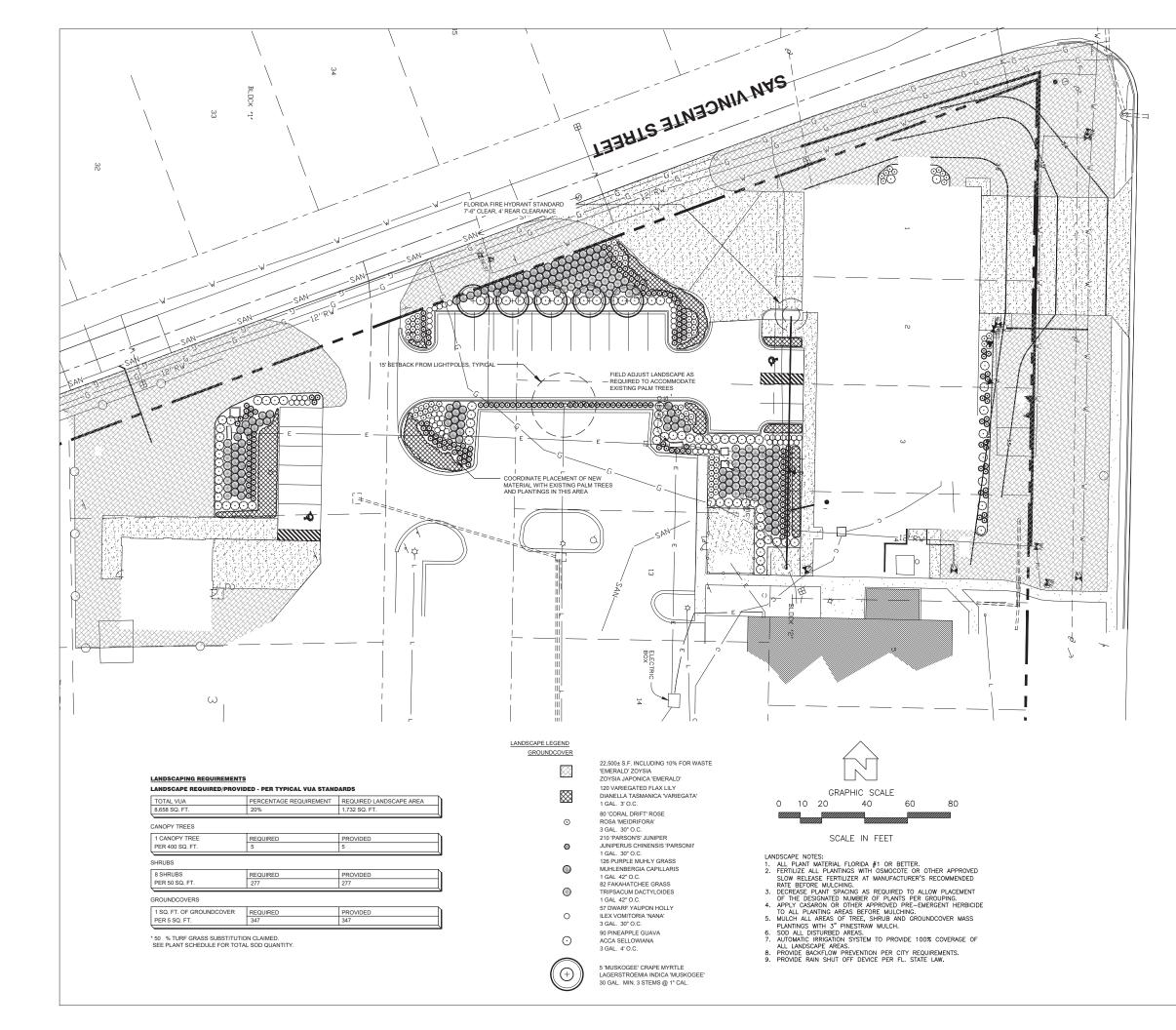
"PCB City Main Campus Map"

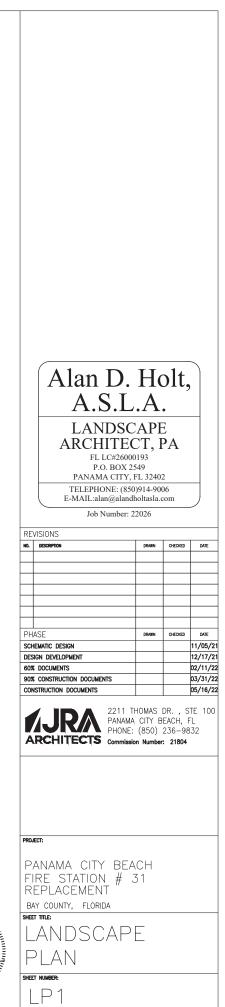

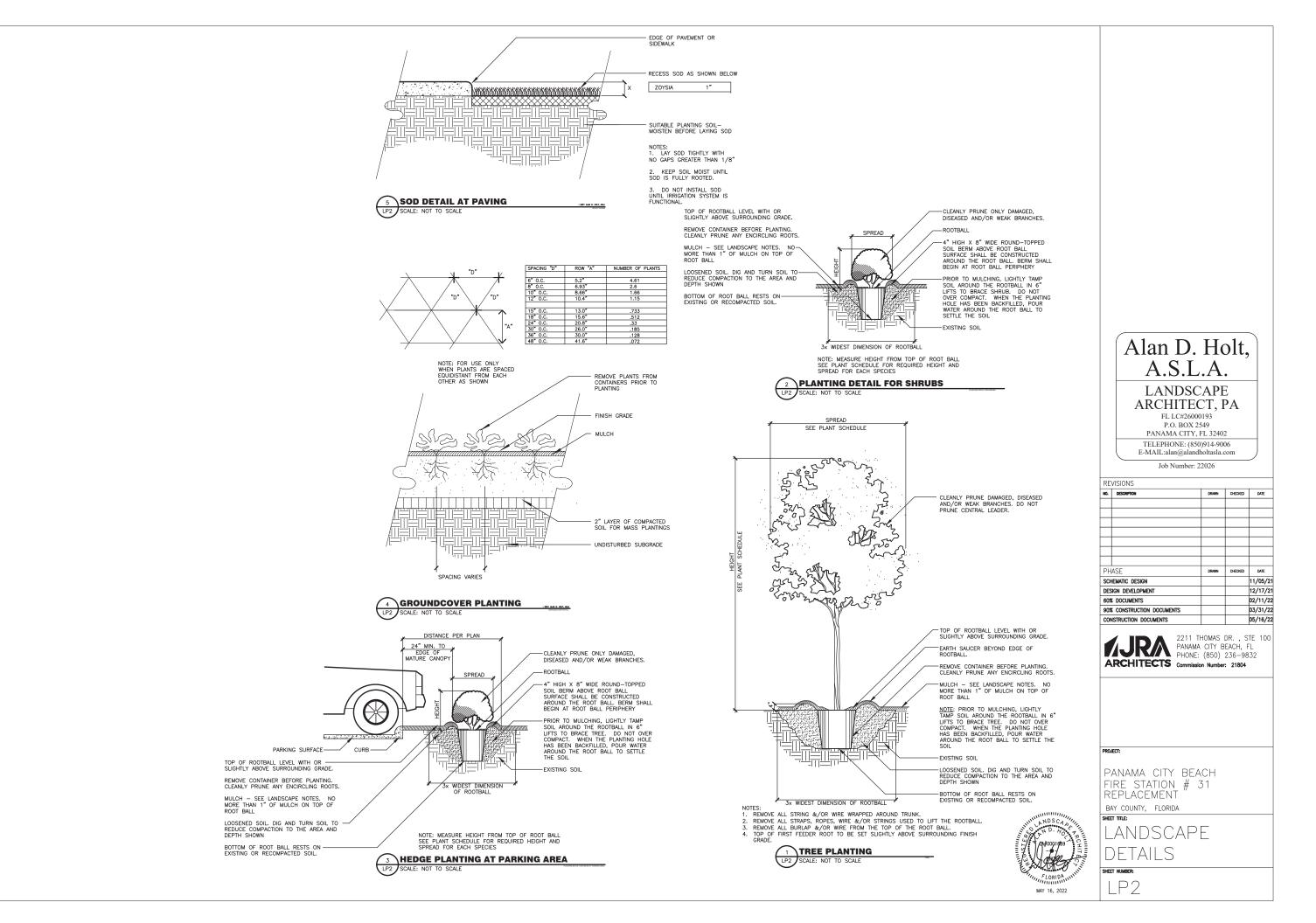

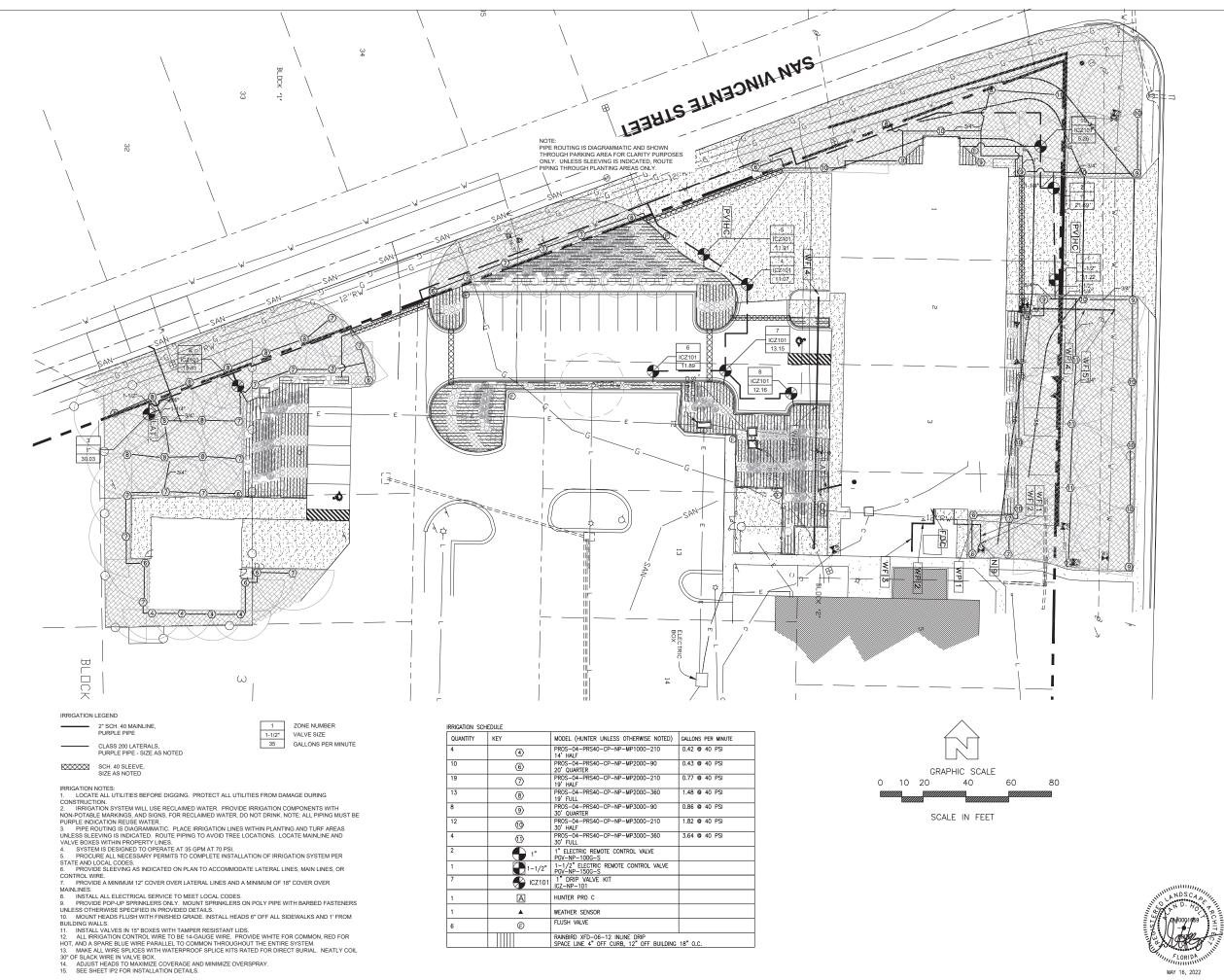
"Landscape Plan for Fire Station #31 and Police / Fire Storage"

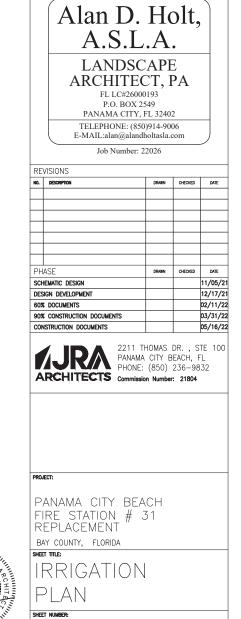




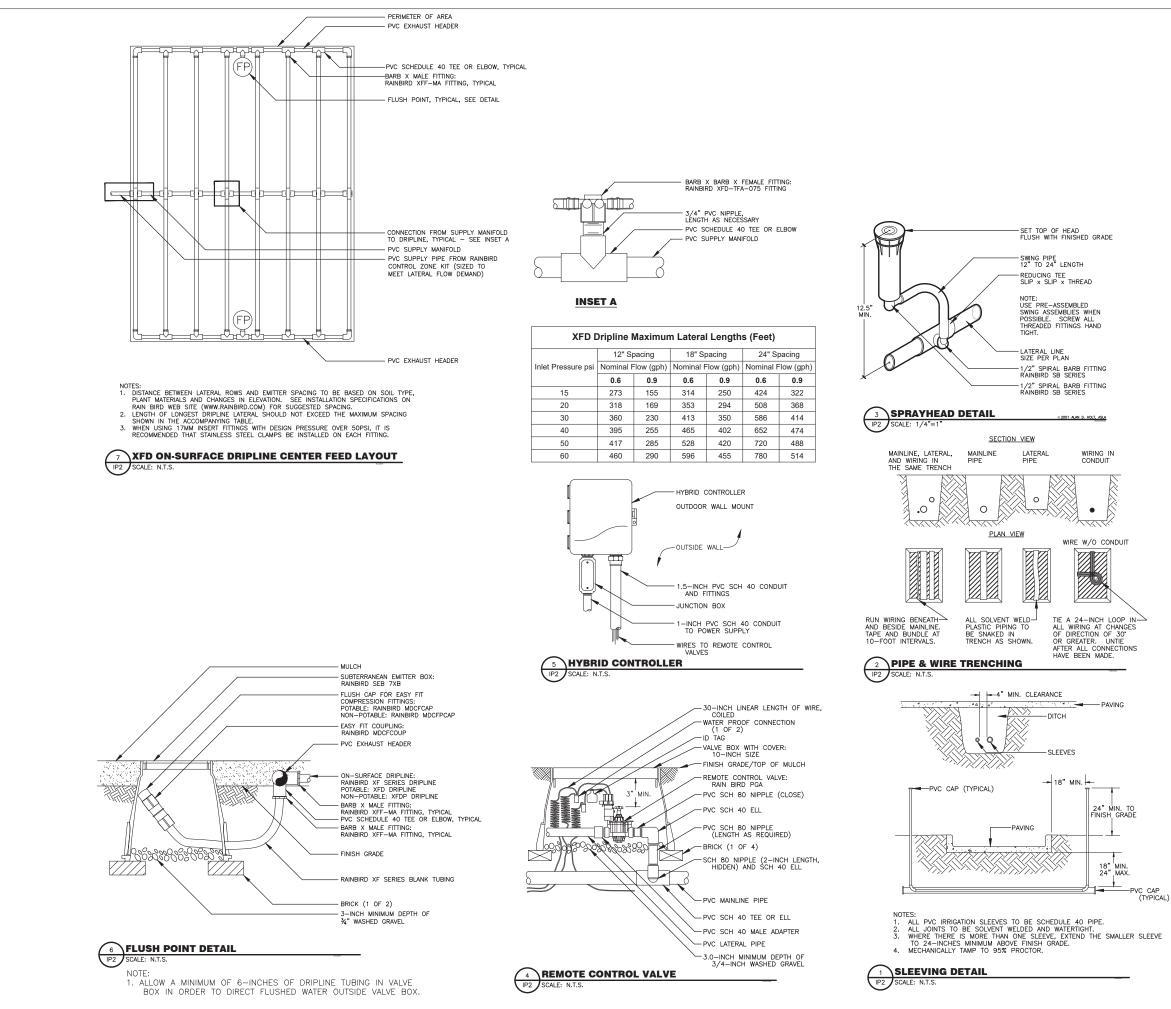






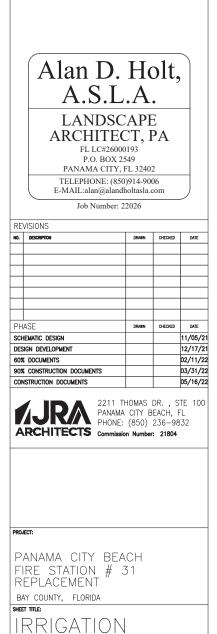
