**ADMINISTRATIVE ORDER 24-24
AN ORDER AUTHORIZING TEMPORARY
ROAD CLOSURES OF CITY STREETS**

WHEREAS, Mark Hess (the “Special Event Holder”) has requested temporary road closure of city streets for the **Florida Jeep Jam** (“Event”) being held on Panama City Beach on May 16 through May 18, 2024; and

WHEREAS, the Event necessitates careful traffic control and extraordinary usage of a portion of **West Park Drive, L C Hilton Drive and South Pier Park Drive** within the corporate limits of Panama City Beach; and

WHEREAS, Section 19-50 of the City’s Code of Ordinances authorizes the City Manager to restrict the use of streets to reduce the risk of damage to persons and property, to facilitate the efficient use of any street or highway, or to reasonably protect the peace and quiet of properties adjoining any street or highway.

NOW, THEREFORE, IT IS HEREBY ORDERED that:

1. A portion of **West Park Drive, between South Pier Park Drive and L.C. Hilton Jr. Drive**, shall be closed and all vehicular traffic shall be controlled in accordance with the **attached** map to accommodate the Event from:
 - a. **4:00 pm to 11:00 pm on Thursday, May 16, 2024,**
 - b. **10:00 am to 9:00 pm on Friday, May 17, 2024, and**
 - c. **8:00 am to 4:00 pm on Saturday, May 18, 2024.**

2. Portions of **South Pier Park Drive, between L C Hilton Drive and Longboard Way**, shall be closed and all vehicular traffic shall be controlled in accordance with the **attached** map to accommodate the Event beginning from **midnight (24:00) on Friday, May 17 to midnight (24:00) on Saturday, May 18, 2024.**

3. **L C Hilton Drive from the Grand Theater, through the traffic circle, to Dave & Busters, and the north side of the L C Hilton traffic circle to the JC Pennys parking lot** shall be closed and all vehicular traffic shall be controlled in accordance with the **attached** map to accommodate the Event beginning from **4:00 pm to 10:00 pm on Saturday, May 18, 2024.**

THIS ORDER shall be effective immediately upon execution.

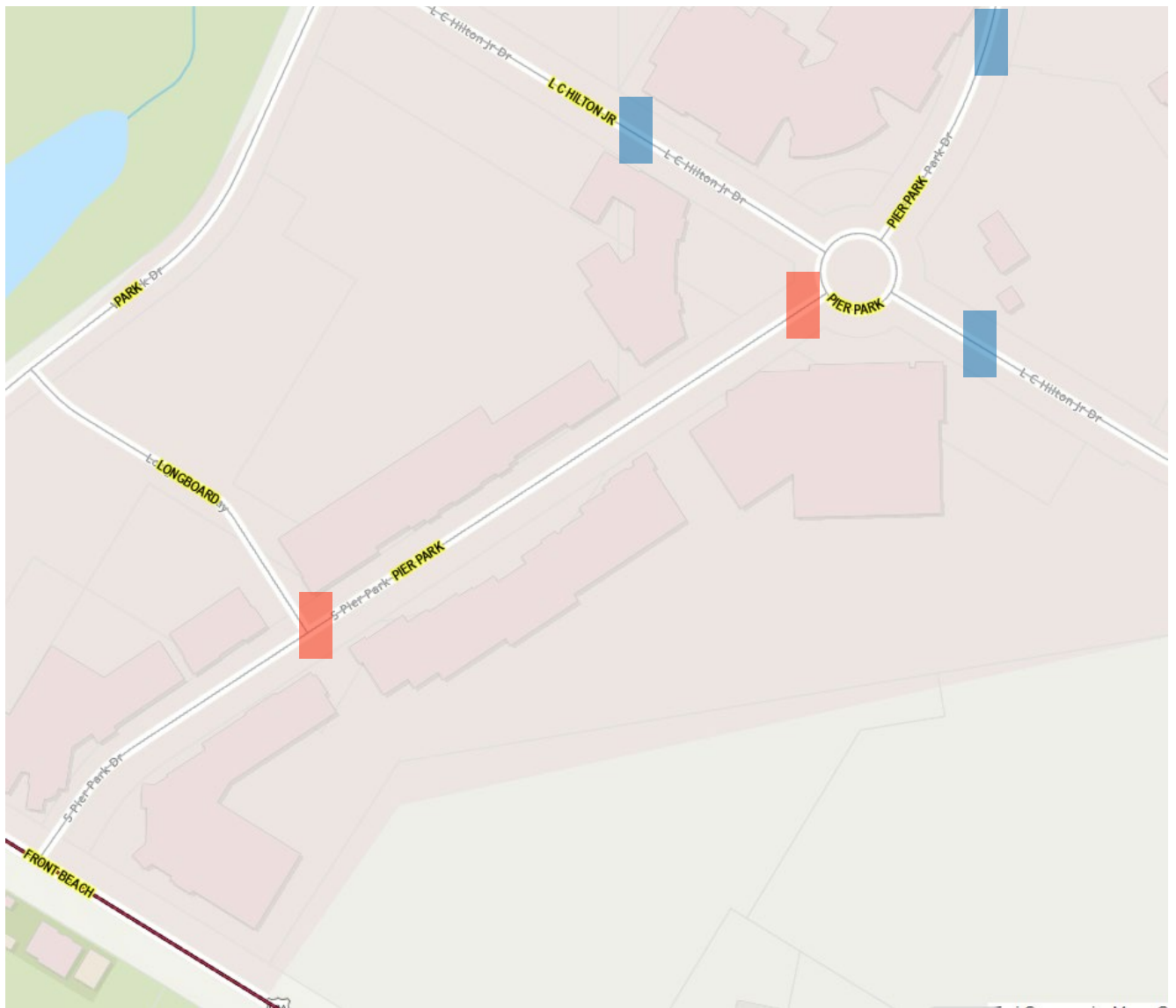
