

RESOLUTION NO. 24-141

A RESOLUTION OF THE CITY OF PANAMA CITY BEACH, FLORIDA, APPROVING THE PURCHASE OF ONE FULLY EQUIPPED 2024 FORD POLICE RESPONDER TRUCK FOR THE POLICE DEPARTMENT FROM ALAN JAY AUTOMOTIVE MANAGEMENT, INC., D/B/A ALAN JAY FLEET SALES, IN THE TOTAL AMOUNT OF \$75,488.00; AGREEING TO BE BOUND BY THE TERMS AND CONDITIONS OF THE CITY OF TALLAHASSEE'S CONTRACT GOVERNING THAT PURCHASE; AND AUTHORIZING A BUDGET AMENDMENT.

BE IT RESOLVED by the City Council of the City of Panama City Beach that:

1. The appropriate officers of the City are authorized to execute and deliver on behalf of the City that certain proposal between the City and Alan Jay Automotive Management Inc., d/b/a Alan Jay Fleet Sales, relating to the purchase of one fully equipped 2024 Ford Police Responder Truck for the Police Department in the total amount of Seventy-Five Thousand Four Hundred Eighty-Eight Dollars and No Cents (\$75,488.00) in substantially the form **attached as Exhibit A** and presented to the Council today, and agree to be bound by the terms and conditions of City of Tallahassee Contract #5179 **attached as Exhibit B**, with such changes, insertions, or omissions as may be approved by the City Manager.
2. The attached budget amendment #26 is adopted for the City of Panama City Beach, Florida, for the fiscal year beginning October 1, 2023, and ending September 30, 2024, to appropriate additional funding for the purchase, as shown on and in accordance with the **attached** and incorporated **Exhibit C**.

THIS RESOLUTION shall be effective immediately upon passage.
