ADMINISTRATIVE ORDER 24-44

**AN ORDER AUTHORIZING TEMPORARY
ROAD CLOSURE OF A CITY STREET**

WHEREAS, Beach Movement Event Management, Inc. has requested temporary road closure of a city street to accommodate the **2024 PCB Oktoberfest** (the "Event") being held on Panama City Beach on Friday, October 18, 2024 through Sunday, October 20, 2024; and

WHEREAS, the Event necessitates careful traffic control and extraordinary usage of a portion of **West Park Drive** within the corporate limits of Panama City Beach; and

WHEREAS, Section 19-50 of the City's Code of Ordinances authorizes the City Manager to restrict the use of streets to reduce the risk of damage to persons and property, to facilitate the efficient use of any street or highway, or to reasonably protect the peace and quiet of properties adjoining any street or highway.

NOW THEREFORE IT IS HEREBY ORDERED, that:

1. A portion of **West Park Drive between South Pier Park Drive and LC Hilton Jr. Drive** shall be closed, and all vehicular traffic shall be controlled in accordance with the **attached** map to accommodate the Event on the following:
 - a) Friday, October 18, 2024 from 4:00 p.m. until 11:00 p.m.;
 - b) Saturday, October 19, 2024 from 11:00 a.m. until 11:00 p.m.; and
 - c) Sunday, October 20, 2024 from 11:00 a.m. until 5:00 p.m.

THIS ORDER shall be effective immediately upon execution.
