ADMINISTRATIVE ORDER 24-47

**AN ORDER AUTHORIZING
TEMPORARY ROAD CLOSURE
OF CITY STREETS**

WHEREAS, Visit Panama City Beach IRONMAN Florida has requested temporary road closures of city streets from **Monday, October 28, 2024 through Sunday, November 3, 2024** in Panama City Beach; and

WHEREAS, the request necessitates careful traffic control and extraordinary usage of portions of South Pier Park Drive, LC Hilton, Sea Monkey Way, Longboard Way, and West Park Drive all within the corporate limits of Panama City Beach; and

WHEREAS, Section 19-50 of the City's Code of Ordinances authorizes the City Manager to restrict the use of streets to reduce the risk of damage to persons and property, to facilitate the efficient use of any street or highway, or to reasonably protect the peace and quiet of properties adjoining any street or highway.

NOW THEREFORE IT IS HEREBY ORDERED that:

1. During the hours of **6:00 AM on Monday, October 28, 2024 through 12:00 PM on Sunday, November 3, 2024**, portions of the following roads shall be closed, and all vehicular traffic shall be controlled in accordance with the **attached** map to accommodate the request:
 - A. **South Pier Park Drive between LC Hilton Drive and Front Beach Road; and**
 - B. **Longboard Way from West Park Drive to South Pier Park Drive; and**
 - C. **Sea Monkey Way east and west of South Pier Park Drive.**

2. A portion of **West Park Drive between South Pier Park Drive and Front Beach Road** during the hours of **2:00 AM on Saturday, November 2, 2024 through 4:00 AM on Sunday, November 3, 2024**, shall be closed and all vehicular traffic shall be controlled in accordance with the **attached** map to accommodate the request.

THIS ORDER shall be effective immediately upon execution.

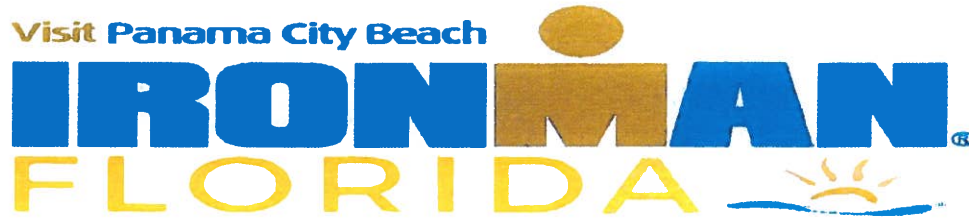
