A Bid Bond in the amount of 5% of the Bid shall accompany the Bid. The City of Panama City Beach (City) reserves the right to reject any and all bids. The City also reserves the right to reject contractors who in the City’s opinion are not qualified to perform the work based on the pre-qualification package. All Bids shall be firm for a period of 90 days after opening. This includes material prices. The bid must conform to Section 287.133(3) Florida Statutes, on public entity crimes.

All bidders shall be FDOT pre-qualified in Major Highway Construction and must show proof of pre-qualification prior to Notice of Award. **All bidders must attend a mandatory “Pre- Bid Meeting” at 3:00 p.m. (CST) on Tuesday, October 18<sup>th</sup>, 2016** at the City of Panama City Beach, 110 South Arnold Road, Panama City Beach, Florida 32413.
