## I. GENERAL CONDITIONS

- 1. The purpose of this bid is to establish a firm, fixed, unit price for two (2) Solar Message Centers in accordance with the Purchasing Policies of the City of Panama City Beach, Florida.
- 2. Award will be made to the responsive, responsible bidder offering the lowest prices for the products requested. The City reserves the right to reject any one or all bids, or any part of any bid, to waive any informality in any bid and to award a contract deemed to be in the best interest of the City.

- 4. In the event a brand name is specified, that brand or *an approved equivalent* will be accepted, even though it may not be stated in those terms in the bid.

#### 6. System Integrity

The Solar Message Center shall be capable of operating independently of sunlight for 21 days using the 2 batteries in the battery bank. The solar array shall be sized to provide one day's power requirement in just 2.5 hours of good sunlight.

Shall be energy-efficient LED display with minimal battery maintenance and long operational life.

### 7. Sign Flexibility

The Message center shall be designed for use in areas where space is limited, and provide variable character fonts with both 12" and 18" character heights.

#### 8. Full Matrix Display

The Message center shall provide no less than 250 text, 60 graphic and 20 arrow board display messages preprogrammed and stored in the controller. Additionally, shall provide 100 user-created messages that can be programmed and stored.

Shall have automatic intensity control for optimum LED intensity and shall have calendar programming capability.
