You are hereby notified by the City of Panama City Beach that the excessive accumulation of abandoned rubbish including a dilapidated camper which has no tag and is currently being used for storage of rubbish, the storage of a junked Chevrolet Camaro which has been severely damaged by fire, the excessive rubbish, junk, and garbage being stored in the back yard, and repair of the dilapidated privacy at the above referenced address constitutes a public nuisance as that term is defined by Sections 15-17(1), 15-17(2), 15-17(3), (15-17(5), and 15-17(6) of the Code of Ordinances of the City of Panama City Beach. The nuisance is located on property in Bay County, Florida, as more particularly described on Exhibit A, attached and incorporated herein. The maintenance of this nuisance on the property is prohibited by Section 15-18 of the City's Code.

For these reasons, YOU ARE HEREBY ORDERED to remove the abandoned rubbish including a dilapidated camper which has no tag and is currently being used for storage of rubbish, the junked Chevrolet Camaro, the excessive rubbish, junk, and garbage being stored in the back yard, and repair the privacy fence in accordance with the Florida Building Code on or before 5 p.m., May 31, 2017.

You are further notified that if you do not commence or complete the yard maintenance necessary to prevent further violation of the above cited sections of the City Code with the time limits set forth above, the City may thereafter undertake all such actions necessary to complete that yard maintenance and abate the nuisance, and assess the entire cost thereof, including administrative, legal, postal, and publishing expenses, against the above described property. This assessment shall constitute a lien superior to all existing liens, except ad valorem taxes.
